Set post 4" dia., 4 ft. long, with marked stone, 12" in ground for gr. sec. cor., marked ¼ S on N. face, from which
Fir 4" dia., bears N.30°W., 33 lks. dist. mkd. ¼ S BT.
Fir 6" dia., bears S.45°W., 15 lks. dist. mkd. ¼ S BT.

Point for the ¼ sec. cor., at proportionate distance; there is no remaining evidence of the original corner.

The ¼ sec. cor., monumented with an iron post 1" dia., firmly set, projecting 8" above ground with brass cap mkd. in 1950, from which the remains of the bearing trees mkd. in 1950:
A burned Fir 60" dia., bears N.63 ¾°W., 43 lks. dist., with healed blaze.
A root hole bears S.64½°W., 40 lks with a down Fir alongside, 23" dia., no marks remaining on burned blaze.
and a new bearing tree:
A burned Fir 50" dia., bears S.34½°W., 102 lks. dist., mkd. ¼ S1 BT.
Set a 6 ft. steel fence post alongside the iron post.
