GLO survey by C. M. Collier under Contract #546, dated August 16, 1889 - (DCSO records Vol. 1 Page(s) 97-98)

I begin at the corner to Townships 19 & 20 South, Ranges 11 & 12 West, on the Coast Meridian, at a point from which

- A Hemlock stump 24" dia., bears N.40°W., 12 lks. dist.
- A Hemlock stump 30" dia., bears N.85°E., 26 lks. dist.
- A Hemlock stump 36" dia., bears S.10°E., 24 lks. dist.
- A Hemlock stump 30" dia., bears S.74°W., 53 lks. dist.

All were considerably decayed, but showed some signs of the original marks, though none decipherable.

I find no remains of the old post so set a new post at proper distance and bearing from said Hemlock bearing tree stumps, 4½ ft. long, 4" sq., 24" in the ground, for cor. to Townships 19 & 20 S. of Ranges 11 & 12 West, marked T19S S31 on NE.; R11W S6 on SE.; T20S S1 on SW.; and R12W S36 on NW. faces, with 6 notches on each edge, from which

- A Fir 10" dia., bears N.49½°E., 11 lks. dist. mkd. T19S R11W S31 BT.
- An Alder 10" dia., bears S.41½°E., 41 lks. dist. mkd. T20S R11W S6 BT.
- An Alder 10" dia., bears S.8¼°W., 22 lks. dist. mkd. T20S R12W S1 BT.
- An Alder 8" dia., bears N.47°W., 37 lks. dist. mkd. T19S R12W S36 BT.

Found - 36" D.Fir N.49½°E., 7.3 ft., cut open and found good scribing.

Remnant of Alder stump N.47°W., 24.4 ft., small fragment of reverse scribing on over growth of old face.

No trace of SE or SW BTs.
