- A Hemlock 4" dia., bears N.71°E., 25 lks. dist.

At place where old cor. to secs. 13, 24, 18 and 19 stood, the stumps of some of the witness trees found. Reestablished this corner by setting post, 6" dia., 4 ft. long in ground with mkd. stone 12", marked T21S S18 on NE.; R5W S19 on SE.; R6W S24 on SW.; S13 on NW. face; with 3 notches on N. & S. edges, from which

- Cedar 27" dia., bears N.40°W., 75 lks. dist. mkd. T21S R6W S13 BT.
- Cedar 14" dia., bears S.60°W., 50 lks. dist. mkd. T21S R6W S24 BT.
- Maple 12" dia., bears S.42°E., 27 lks. dist. mkd. T21S R5W S19 BT.
- Hemlock 8" dia., bears N.10°E., 45 lks. dist. mkd. T21S R5W S18 BT.

Found - Cedar tree, now 30", S.60°W., 33.0 ft., previously opened, scribing "S24 T21S R6" visible on old face, tree nearly dead, whole inside, including face, rotting badly.

Cedar tree, down an dead, N.40°W., 49.5 ft., no scars or scribing found, one whole side burned away.

No trace of NE. or SE. bearing trees.
