A 17" Maple bears N.82°E., 67.0 ft. Tree is alive with visible scribing "WC CS BT" in double blaze.  
Found no trace of bearing objects. (SW one in swamp area. NW one has tree uprooted over area.)

New BT - 12" Fir bears N.5°W., 49.0 ft. scribed "WC 1/4 CS BT" in double blaze.

True corner lies in marsh.
