The old cor. and bearing trees being destroyed,  
Set a post 4½ ft. 4" sq., 24" in the ground, for cor. to secs. 25, 36, 30 and 31, marked T21S S30 on NE.; R11W S31 on SE.; R12W S36 on SW.; S25 on NW. face, with 5 notches on N. and 1 notch on S. edge, from which

- A Fir 36" dia., bears N.69°E., 77 lks. dist. mkd. T21S R11W S30 BT.
- A Fir 36" dia., bears N.56½°W., 107 lks. dist. mkd. T21S R12W S25 BT.

No other trees within limits, I raised a mound of stone, 1½ ft. high, 2 ft. base alongside; pits impracticable. I found here 4 trees corresponding in size and kind to the bearing trees of former surveys lying on the ground, being blown down.
