Elk Creek, 150 lks. wide, from N.30°E., course S.60°W.; from this point the original witness point on the right bank of Elk Creek, established by Gordon and Gardner, in 1855, bears North, 2.03 chs. dist., perpetuated and recorded by Godfrey in 1962, monumented with an iron post, 1" dia., firmly set, extending 6" above the ground, with 1962 brass cap, from which the remaining original bearing tree:

A double Cedar 45" dia., bears N.11½°W., 42 lks. dist., with scribe marks S T22 R7W BT visible on partly healed blaze.
