Found - 1/2" dia. Iron rod, protruding 2½ ft. above ground. Source unknown, possibly set in area of corner from a recent survey. I.R. is loosely set. DCS0 BC/IP not found.

10" now 18" dia. D.Fir with a fully healed double blaze, bears N.77½°E., 21.6 ft. (Rec. N.77½°E., 24.0 ft. dist. could be a slope measurement)

14" now 23" dia. D.Fir with a fully healed double blaze, bears S.40°W., 60.2 ft.

10" now 12" dia. Maple with a fully healed single blaze, bears N.86½°W., 41.5 ft. (Rec. West, 41.5 ft., bearing to Maple is difficult to see)

At a position determined from bearing trees that were scribed in 1971, SET a 2 3/8" dia. Brass cap on a 1 3/8" O.D. x 32" long iron pipe, protrudes 6" above ground and is marked:
