A Cedar 30" dia., bears S.42°W., 26 lks. dist. mkd. T22S R11W CC S19 & 30 BT.

40" Cedar bears S.42°E., 53 lks.; now 61", grown over, recent scribes BT CC S30 T22 R11 399 visible.
30" Cedar bears S.42°W., 26 lks.; now 40", grown over, recent scribes BT CC S25 T22 R11 visible.
Stream, 1 lk., course NE, bears North 49 lks.; in place.
Set 1½" x 36" galv. I.P. with 3" bronze cap mkd. "Ore. St. Bd. of Forestry T22S R12W R11W S25 S19 S30 CC 1960 RS359", 33" in ground with corner stone alongside, from which

49" Cedar, 1960, N.83½°W., 26.3 ft.; now 60" x 5 ft. high stump, scribes visible, in place.
