Possible evidence of 2 1893 OBTs -  
A very rotted fir stump with no remaining blaze evidence; bears S.59°E., 53.7 ft. (as per computed 2005 BLM rec.)  
An approx. 50" dia., sawn and rotted D.Fir stump with marks visible; bears S.9½°W. 75.0 ft. (as per computed 2005 BLM Rec.)  
From the 1960 DCSO renewal a brass cap monument marking the 1893 corner position. -  
A 2½" dia., on a 1" I.D. IP, projecting 13" above ground, bears N.0°18'10"E., 2.17 ft (as per BLM 2005 rec.) brass cap mkd:
