A Fir, 24" dia., bears S.45°E., 154 lks.
A Fir, 60" dia., bears S.45°W., 6 lks.
A Fir, 50" dia., bears N.55°W., 36 lks.

GLO resurvey and retracement by Levi C. Walker under contract #763, dated Aug. 23, 1905 - (DCSO records Vol. 7 Page(s) 2729-30)

The orig. cor. changed to Secs. 14 & 23 only
The intersection being beyond allowable closing limits.
I retrace my work & finding it correct, I proceed to establish my random line as a true line by setting a CC of secs. 15 & 22, marked CC T23S R10W on W, S15 on N, & S22 on S face, with 3 grooves on S & 2 grooves on E face; from which
A Fir, 6" dia., bears S.27°W., 27 lks., mkd: T23S R10W S15 BT.
A Hemlock, 12" dia., bears S.85°W., 38 lks., mkd: T23S R10W S22 BT

25" Hemlock bears N.63°W., 67.1 ft., scribed T23S R10W S15 CC BT.
Section corner 14 & 23 bears South 1.57 chs.
4"x4"x72" White painted Cedar post 2.0 ft. N.30°W., of corner pipe.
