A sawed Oak stump 26" dia., bears S.32¾°E., 370 lks. dist., with opened blaze, no marks visible. (Record, S.31°E., 368 lks.)  
An Oak 37" dia., bears N.8¾°W., 810 lks. dist., with scribe marks BT visible on opened blaze & scribe marks ¼ S12 visible on partially healed blaze. This tree was remarked by Claude Kerr in 1954 (Record, N.6½°W.)  
and BT mkd. by Godfrey  
An Oak 22" dia., bears N.87°E., 387½ lks. dist., with scribe marks ¼ S7 CS BT visible on partially healed double blaze.  
Add marks BLM 1964 to bottom of brass cap.  
From this point, a point established by Kerr, in 1954, bears S.79°30'W., 0.12 chs. dist., monumented with an I.P. ½" dia., firmly set, protruding 12" above the ground.

Found - 1" x 36" I.P. laying in crotch of tree, bent, with 1961 DCSO brass cap w/BLM 1964 mark.  
A ¾" x 30" I.P. bent & mangled (obviously dislocated) bears N.72°W., 7.6 ft. from corner reset from BTs. (Rec. set by kerr, 1954, a ½" I.P. bears S.79½°W., 7.9 ft. according to BLM 1964, S.80°W., 7.8 ft. according to Godfrey.  
24" now 37" W.Oak bears N.7°W., (Rec. N.6½°W) 534.6 ft. with visible scribing "S12 BT" in partly healed upper blaze & "BT" in chopped open lower blaze. A 9" high "K" is carved in south side of tree. (OBT)  
20" now 24" W.Oak bears N.87°E., 255.9 ft. with a well healed blaze.  
Set - I straighten & reset brass cap, 0.4 ft. above ground, with distances controlling placement using Hewlitt Packard electronic measurement to O.B.T. & transit/steel tape measurements on all other distances. I stamp "RESET 1977" above "BLM 1964".  
New BT - 12" Walnut bears S.33°W., 5.6 ft. but I do not mark tree.  
Set a steel fence post 1.0 ft. south of BC with survey marker sign attached. Cor. is approx. 80 ft. south of Co. Rd. in old walnut orchard.
