(DCSO records, Vol 10 Pgs 4255)</p> <p>-----</p> <p>1/4 cor. post, which is a fir post, firmly set, marked and witnessed as described by the surveyor general. This is probably not the original cor. post, but it is set in the original mound of stone and was evidently placed there to perpetuate the old cor., which had become decayed.</p>

Topog call fit well.</p> <p>Set - 2½" DCSO alum cap on ⅝"x30" iron rod, set 4" above top center of found stone mound. Cap mkd: DOUGLAS COUNTY ¼ S25 S30 SURVEYORS OFFICE</p> <p>New - 20" Hemlock N.12½°E., 34.3 ft scribed "T26 ¼ S30 BT" on double blaze. 9" singed D.Fir N.81°E., 13.5 ft scribed "¼ S30 BT" on double blaze. 9" singed Fir, S.2½°W., 25.7 ft. scribed "¼ S25 BT" on double blaze.
