GLO survey by Fred Mensch, US Deputy Surveyor, under contract No. 797, dated April 19, 1910 - (DCSO records Vol. 25 Page(s) 10574 & Vol. 26 Page 10973)

Set a basalt stone 18x9x6", 12" in the ground for ¼ sec. cor. mkd. ¼ on N face, from which
A fir, 12" dia., bears N.35°W., 30 lks., mkd: ¼ S36 BT.
A yew, 8" dia., bears S.61°W., 27 lks., mkd: ¼ S1 BT.
The S. fork of South Umpqua River bears S. 75 lks.

GLO resurvey by Norman D. Price, Cadastral Engineer, Leonard Carter, Public Land Surveyor, and George F. Dawson Jr., Transitman, under Group No. 175 surveyed April/Aug. 1937 - (DCSO records Vol. 34 Page(s) 14073B-14074)

The orig. ¼ sec. cor. of secs. 1 & 36, which is a washed boulder, 15x8x6" firmly set, mkd. ¼ on N face. Hereafter this cor. will refer to sec. 36 only.

At point for corner,
Set an iron post, 3 ft. long, 1" dia., 27" in the ground, with the orig. stone deposited at the base, for ¼ sec. cor, of sec. 36 only, with brass cap marked: ¼ S 36

from which
A fir, 15" dia., bears N.35°W., 30 lks., blazed healed; I do not open. (Old BT)
A yew, 10" dia., bears S.63¼°W., 27 lks., mkd. ¼ S1 BT. I obliterate the marks on this tree (Old BT)
A cedar, 14" dia., bears S.47½°E., 67 lks., mkd: ¼ S36 BT. (Old BT)

Dennis Gaylord, USFS & Deputy Co. Surveyor - Witness: Walter Barton - March 3, 1977 - C.S. File 59/31-3

Found - 1937 U.S. GLO brass cap mkd. ¼ S36. Township & range not stamped on brass cap. Pipe bent over approx 45°. Straightened pipe & placed a mound of stones around it, 2'x2'x1½ high.
A 24" Cedar bears N.47°30'E., 43.5 ft. Has a healed blaze. (rec. N.47½°E., 44.22)
A 25" Fir stump, uprooted, orig. location, bears N.35°W., 19.8 ft. Chop out & find fragmentary scribing.
A 11" Yew bears S.62°W., 17.82 ft.. Scribing visible on nearly healed blaze., ¼ S1 BT"
Place County BT tags on cedar & yew. Both are alive & in good condition.

New BT - A 12' Yew bears N.5°W., 21.1 ft. scribed "¼ S36 CS BT" on a double blaze. & a county BT sign placed on tree.

Note - Corner is 200' more or less south of Forest Service Rd. #293 and 30 ft. more or less northeast of the North bank of Jackson Creek.
