Found - 1992 BLM 3" brass cap.
26" D.Fir S.52°E., 31.4 ft. healed face.

The ¼ sec. cor. of secs. 1 & 6, reestablished at proportionate distance by Thompson, in 1958, there is no remaining evidence of the original corner, therefore, this position is accepted as the corner; monumented with an iron pipe, 1" diam., loosely set, projecting 12" above ground, from which bearing trees mkd. by Thompson:

A fir, 26" dia. bears S.52½°E. 47 lks. w/healed double blaze
A fir, 21" dia. bears S.76½°W. 66 lks. w/healed double blaze

At the corner point

Set a stainless steel post, 28" long, 2½" diam., 22" in the ground, with brass cap mkd.
