A Fir 12" dia., bears S.5°E., 65 lks. dist. mkd. T30S R2W S19 BT.
A Cedar 5" dia., (now 10") bears S.60°W., 25 lks. dist. mkd. T30S R3W S24 BT.
A Fir 12" dia., bears N.55°W., 58 lks. dist. mkd. T30S R3W S13 BT.
