The 1/4 sec. cor., perpetuated and recorded by Powell in 1969, monumented with the remains of the original corner tree, a sawed Fir stump, 44" dia., no marks visible, from which the original bearing trees:

A Cedar 33" dia., bears S.82°E., 44 lks. dist., no marks visible. (Rec. S.85°E.)

A Fir 41" dia., bears N.86°W., 36 lks. dist., no marks visible. (Rec. N.80°W.)

and bearing trees and a reference monument mkd. by Powell

A Fir 17" dia., bears N.16°E., 39 lks. dist., with healed double blaze.

A Cedar 18" dia., bears S.58°W., 30 lks. dist., with scribe marks 1/4 S5 CS BT visible on open double blaze.

An iron post, 1 1/4" dia., firmly set, projecting 12" above ground, bears West, 0.036 chs. dist., with brass cap mkd. COUNTY SURVEYORS OFFICE T31S S32 S5 R7W T32S 1969.
