The $\frac{1}{4}$ sec. cor., perpetuated and recorded by Price in 1954, subsequently perpetuated and recorded by Powell in 1967, monumented with an iron post, 1" dia., firmly set, projecting 12" above ground, with brass cap properly mkd.

A Pine snag 45" dia., bears S.5 $\frac{1}{2}$ °W., 102 lks. dist., no marks visible. (Rec. S.4°W.) This tree was rescribed $\frac{1}{4}$ S R8W RS33 BT.

A Ponderosa Pine 7" dia., bears N.43 $\frac{3}{4}$ °E., 28 lks. dist., with scribe marks $\frac{1}{4}$ S7 CS BT visible on partially healed double blaze.

A Fir 12" dia., bears S.12 $\frac{1}{2}$ °W., 38 lks. dist., mkd. $\frac{1}{4}$ S12 BT.
