A Fir 12" dia., bears S.63°15'E., 137 lks. dist., marked T33S R4W S3 BT.

A Fir 4 ft. dia., bears S.89°W., 80 lks. dist., marked T33S R4W S3 BT.

A Fir 12" dia., bears N.55°30'E., 111 lks. dist., marked T33S R4W C C S3 and 4 BT.

This cor. is 300 ft. above creek at 42.53 chs.

A Fir 7" dia., bears S.88½°W., 20 lks. dist., mkd. T33S R4W S4 CC BT.

From this point, the original closing cor. of sec. 3 and 4, bears N.0°42'E., 0.045 chs. dist., determined at record bearing and distance from the remains of the original bearing trees:

A Fir root crown, size indeterminate bears N.55½°E., 111 lks. dist., no marks visible.

A root hole bears S.63¾°E., 137 lks. dist.

A burned Fir stump 38" dia., bears S.89°W., 80 lks. dist., with burned blaze.
