Resurvey of Charles W. Beckworth Land Claim No. 39. T. 30 S. R 4 W. in secs. 7 and 8. Notification No. 136

Begin at the SE cor. of claim 39 and SW. corner of Claim No. 46. The post set for this cor. is gone; but the body of an oak, corresponding in size, bearing and distance with the description, given in the field notes furnished me, is lying here now; Mr. Boyle, who has lived here for 30 years, informs me, that this is the old bearing tree. I restore this cor. by setting a basalt stone 11 x 8 x 6 ins. in a mound of stone, marked #39 on NW face, from which

An alder 16 ins. in diam. bears S 84° E 10 lks dist., marked T 30 S R 4 W C. 46 BT.

An alder 12 ins in diam., bears S 46° W 8 lks. dist., marked T 30 S R 4 W. C. 39 BT.

Thence

North bet Claims No 39 and 46.

Va 18° E.

1.00 A branch, 10 lks. wide, course S 10° W. Offset East 75 lks. as the line recrosses this branch several times.

10.50 Offset West 75 lks., regained true line at NE cor. of Claim No. 39 and interior angle cor. of claim No 46. The post, set for this cor is gone, but the stump of an oak, corresponding in size, bearing and distance, namely N 10 1/2° W 32 lks. agreeing with the description in the field notes form of survey of claim 46, furnished me, is standing, still showing parts of letters BT., the other bearing tree was standing in what is now a grain field, and all traces of the same have disappeared. (Note, this line disagrees in length with the original survey; the owners of the land on both sides of the line, being aware, long ago of the discrepancy, settled it, by owner of claim No. 39 selling to the other, all that square, which lies North of the Claim No. 44.) I restored this cor. by setting an oak post 4 1/2 ft. long, 4 ins. square, 24 ins. in the ground, marked T 30 S. R 4 W C. 39 on NE face, from which

A bl. oak 48 ins. in diam., bears N 57 1/2° W. 34 lks dist., marked T 30 S. R 4 W C. 46 BT. Thence

Var. 18° 12' E
