

Dependent Resurvey, Portion of Subdivisional Lines,  
T. 22 S., R. 7 W., Willamette Meridian, Oregon

CHAINS

A fir, 7 ins. diam., bears N.  $16\frac{1}{2}^\circ$  W., 43 lks.  
dist., mkd. T22S R7W S19 CCC BT.

From this point, the SE. cor. of Claim No. 41, bears  
N.  $88^\circ 56'$  W., 9.89 chs. dist., hereinafter described.

Ascend 105 ft. over SE. slope.

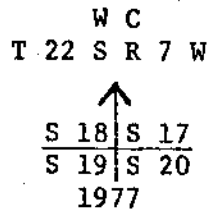
19.90 Top of ascent, slopes E.; desc. 50 ft. over NE. slope.

23.05 Ravine, drains S.  $60^\circ$  E.; asc. 195 ft. over SE. slope.

34.80 Ridge, bears E. and W.; desc. 15 ft. over NE. slope.

35.08 Point for the witness cor. to secs. 17, 18, 19, and 20,  
at proportionate distance; there is no remaining evidence  
of the original witness corner.

Set an iron post, 28 ins. long,  $2\frac{1}{2}$  ins. diam., 22 ins.  
in the ground, with brass cap mkd.

A fir, 5 ins. diam., bears N.  $48^\circ$  E., 5 lks.  
dist., mkd. X BT.

A chinquapin, 8 ins. diam., bears S.  $32^\circ$  E.,  
 $30\frac{1}{2}$  lks. dist., mkd. X BT.

A fir, 9 ins. diam., bears S.  $30\frac{1}{2}^\circ$  W.,  $31\frac{1}{2}$  lks.  
dist., mkd. X BT.

Descend 225 ft. over NE. slope.

40.09 True point for the cor. of secs. 17, 18, 19, and 20.

Land, rolling hills.  
Soil, rocky clay.  
Timber, fir, hemlock, cedar, maple, alder, madrone,  
cascara, and chinquapin; undergrowth, hazel, arrowwood,  
huckleberry, vine maple, poison oak, Oregon grape,  
rhododendron, and fern.

Dependent Resurvey of a Portion of the North Boundary  
of Donation Land Claim No. 39,  
T. 22 S., R. 7 W., Willamette Meridian, Oregon

(Restoring the survey by Dennis Hathorn,  
U. S. Deputy Surveyor, in 1858)

From the NE. cor. of Donation Land Claim No. 39, in  
sec. 20, determined at record bearing and distance from  
the remains of an original bearing tree:

A decayed oak stump, size indeterminate, bears  
S.  $6^\circ$  W., 59 lks. dist., with axe marks visible  
on NE. face.
