GROSS PROPERTY AT CANYONVILLE, ORE.

A tract of land the boundaries of which are described as follows, BEGINNING at a point on the east line of the Jackson Reynolds Donation Land Claim No. 58, Twp. 30 S; Rg. 5 W; W.M; which is 24.02 chains North of the S.E. corner of said Claim, said beginning point being at the North East corner of the property which is recorded in county clerk's files in Volume 102, Page 15, thence running West 28.39 chains, along the North side of said recorded tract, to a point thence N.20°W. 1.0 chain thence West 1.4 chains, thence N.46°W. 6.0 chains to the S.E. corner of what was known as the "Tollgate Lot", thence S.72°43'E. 1.88 chains thence East 11.5 chains thence N.18°W. 23.84 chains thence S.84°-28'E. 11.85 chains, thence West 1.43 chains to a point on the West line of said Reynolds Donation Land Claim which is 3.28 chains South of the Interior "L" corner of said Donation Claim, thence N.10°E. 13.7 chains thence S.59°W. 4.78 chains to a point on the West line of said Donation Claim which is 9.5 chains South of the N.W. corner of said Donation Claim, thence S.34°E. 8.58 chains thence N.76°E. 2.87 chains, thence N.80°-45'E. 3.16 chains, thence East 12.55 chains or to the most westerly corner of the tract of land which is recorded in county clerk's files in Volume 101, Page 342, thence running S.40°-12'E. 28.9 chains along the southwesterly side of said tract as recorded in Vol 101, to a point on the East side of said Reynolds Donation Claim, thence is S.0°-10'W. 14.75 chains, ~~from~~ West 1.82 chains from the section corner common to sections 26, 27, 34 and 35, T. 30 S; R. 5 W; W.M; thence South 20.65 chains, along the East side of said Reynolds Donation Land Claim, to the place of beginning, containing 102.0 acres, more or less, and situated in Sections 27 and 34, Twp. 30 S Rg. 5 W; Willamette Meridian, Douglas County, Oregon.
