ORDER

The above entitled matter having come on regularly for hearing on January 3, 1958, based upon petition filed in the above entitled case on December 2, 1957 by Cecil Luellen, et al, and it appearing to the satisfaction of the Court that all proceedings have been properly complied with in accordance with the requirements of ORS 271.010 and 271.020, and that no opposition has been made to said petition, and that the matters prayed for by said petition should be granted.

Now, therefore,

IT IS CONSIDERED, ORDERED, ADJUDGED AND DECREED that the properties as below described shall be and the same hereby are vacated as public streets designated in the plat of Umpqua Park Fruit Lands on file in the office of the County Clerk of Douglas County, Oregon, to-wit:

(a) The following portion of Eugene Street is hereby vacated:

So much of said Eugene Street which is located within Umpqua Park Fruit Lands plat on file in the office of the County Clerk of Douglas County, Oregon, as lies westerly of the westerly boundary line of U. S. Highway 99 and easterly of a line identified as follows: Extending the westerly boundary line of Lot 4, Block 4 in said Umpqua Park Fruit Lands plat in a straight line in a northerly direction across said Eugene Street to the southwest corner of Lot 4, Block 3 in said Umpqua Park Fruit Lands; and

(b) The following portion of Portland Street is hereby vacated:

So much of said Portland Street which is located within Umpqua Park Fruit Lands plat on file in the office of the County Clerk of Douglas County, Oregon, as lies westerly of the westerly boundary line of U. S. Highway 99 and easterly of a line identified as follows: Extending the westerly boundary line of Lot 4, Block 2 in said Umpqua Park Fruit Lands plat in a straight line in a northerly direction across said Portland Street to the southwest corner of Lot 4, Block 1 of said Umpqua Park Fruit Lands.
