AN ORDINANCE VACATING A PORTION OF FISHER DRIVE LOCATED IN GLEN OAKES ADDITION TO THE CITY OF ROSEBURG, ROSEBURG, OREGON, AND DECLARING AN EMERGENCY.

WHEREAS, heretofore by resolution duly and regularly adopted the Common Council of the City of Roseburg, Oregon, did initiate proceedings for the vacation of a portion of Fisher Drive located in Glen Oakes Addition to the City of Roseburg, Roseburg, Oregon, which are hereinafter more particularly described; and

WHEREAS, the said proposal was by said Common Council referred to the Planning Commission of the City of Roseburg, Oregon, and said Planning Commission did make its report to said Common Council recommending the vacation of said portions of said public street, after first holding a public hearing thereon; and

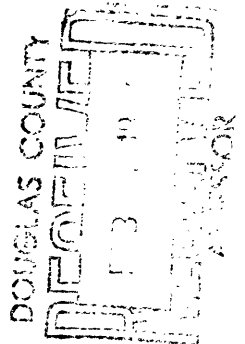
WHEREAS, following the receipt of said recommendation, the Common Council of said City did give notice of its intent to vacate said portion of said public street by posting the same on said portion of said street sought to be vacated in the manner required by the statutes of the State of Oregon and by publication of said notice in the Roseburg News Review, the official newspaper of said City, once each week for four consecutive weeks, all of which more fully appears from the proof of said posting and publication on file in the office of the City Recorder of said city and which said notices described the portion of said public street sought to be vacated, designated the date upon which a public hearing thereon would be held by said Common Council and advised that any and all remonstrances thereto would be heard by said Common Council on the date so designated; and

WHEREAS, said Common Council on the date so designated did hold said public hearing and remonstrances to said proposed vacation were made and none are now made.

NOW THEREFORE, BE IT ORDAINED BY THE PEOPLE OF THE CITY OF ROSEBURG:

Section 1. That the following portion of Fisher Drive, located in Glen Oakes Addition to the City of Roseburg, Oregon, as said subdivision is platted and of record in the office of the County Clerk of Douglas County, Oregon, be and the same hereby is vacated, to-wit:

BEGINNING at the Northeast corner of Lot 3, Glen Oakes Addition to the City of Roseburg as platted and filed in the office of the County Clerk, Douglas County, Oregon, thence North 88° 25' West 21 feet, thence North 13° 15' West 60 feet to the South line of Lot 4, Glen Oakes Addition; thence South 88° 25' East 20.3 feet to the Southeast corner of said Lot 4, thence South 13° 57' East parallel to the center line of Fisher Drive and 20 feet in the Westerly direction therefrom to the point of beginning.



Section 2. That inasmuch as certain improvements and developments in the area of the portions of said street are contemplated for immediate construction and such construction cannot commence until this Ordinance becomes effective, it hereby is declared that an emergency does exist and that the immediate passage of this Ordinance shall be necessary for the health, peace and safety of the City of Roseburg and its inhabitants and this Ordinance shall become effective immediately upon its passage by the Common Council and approval by the Mayor.
