ORDINANCE NO. 674

AN ORDINANCE PROVIDING FOR THE STREET NAME CHANGE OF FRONTAGE STREET TO FRONTAGE COURT AND DECLARING AN EMERGENCY.

The City of Reedsport ordains as follows:

Section 1. The street name of Frontage Street is hereby changed to Frontage Court.

Section 2. The City Recorder is directed to file certified copies of this Ordinance with the County Clerk, County Assessor and County Surveyor immediately upon its passage.

Section 3. The Common Council desires and deems it necessary and advisable for the immediate preservation of the health, peace and safety of the citizens of the City of Reedsport that this Ordinance become effective at once for the reason that the name Frontage Street is similar in nature to other streets in the City of Reedsport which can cause confusion and delay on the part of emergency agencies, such as fire and police, when responding to public calls for assistance. Therefore, an emergency is hereby declared to exist; and this Ordinance shall be in full force and effect from and after its passage and approval.

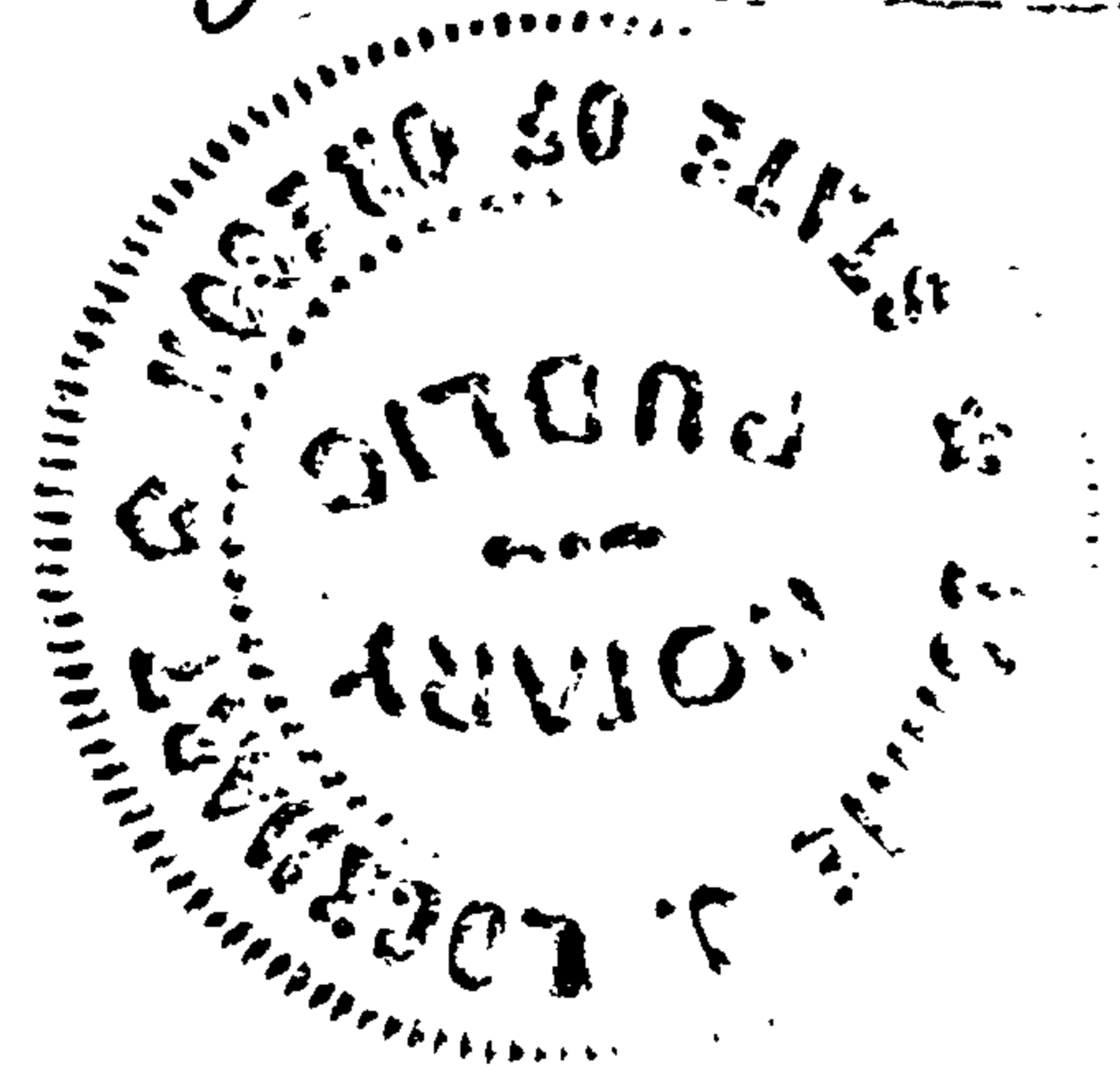
