12 was erroneously included on the original plat.

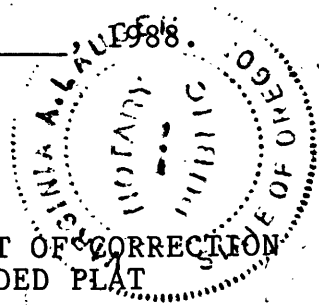
13 The names of the present owners of the property shown
