Purpose: To monument the Northeast 1/16 Corner and
Center East 1/16 Corner of Section 21, also to
mark true line as shown on accompanying plat.

Date: January 8, 1990

Basis of
Bearing: Based upon the North line of the NE 1/4 of
Section 21 per official B.L.M. plat.

Procedure: Utilizing a Wild T-2, Wild T-16 and Mac 1E EDM
and Red 2L EDM, tied North, East, South, West
Quarter Corners, NE, SE and NW Section corners
of Section 21 and the North 1/16 corner common
to Sections 21 and 22.

Holding the North and East 1/4 corner
positions, I calculate the position of the
Center 1/4 corner, which was not set on this
survey. At the calculated position of the NE
1/16 corner, I set:

A 5/8"x30" rebar with yellow plastic cap marked
"TEMPLIN 2359", from which I scribed the
following bearing trees:

A Douglas Fir, 11" diameter bears S 18° E, 13.6
feet, scribed "NE1/16S21" "BT".
A Douglas Fir, 10" diameter bears N 84° W, 14.0
feet, scribed "NE1/16S21" "BT".

I then run S 00°57'23" E, 1275.38 feet to the Center East 1/16 corner and set:

A 5/8"x30" rebar with yellow plastic cap marked "TEMPLIN 2359", from which I scribed the following bearing trees:

A Douglas Fir, 36" diameter bears S 66 1/2°E, 27.5 feet, scribed "CE1/16S21" "BT".

A Douglas Fir, 18" diameter bears S 14° E, 24.5 feet, scribed "CE1/16S21" "BT".

I then run true line as shown on accompanying plat, marking said line by blazing, painting red and posting with 2" x 2" aluminum tags.
