CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: This corner was originally established in 1968 by Thomas E. Shrum under Survey M 37-17. Shrum's Corner was not accepted and the corner was reestablished in 1980 by Quimby and Ware under Survey M 79-37 for the U.S. Forest Service (Contract 53-04H1-9-7490N) as follows:

Set 2 1/2" iron pipe with brass cap marked:

from which bears scribed new B.T.'s:
13" Hemlock N.7°W., 53.6' "C 1/4 S6 BT"
26" D. fir S.70°E., 78.8' "C 1/4 S6 BT"
found aluminum cap on 1" iron pipe N.3°44'53"W., 1.93'
72" D. fir bears N.32°W., 37.2' visible scribes
34" D. fir bears S.81°W., 42.5' visible scribes

Description of corner evidence found:

A 2 1/2" (O.D.) iron pipe, firmly set, flush with the ground with a 2 1/2" brass cap stamped:

T28S R2W
C 1/4 • S6
RLS 1005
1980

from which bearing trees by Quimby and Ware in 1980:
a 19" Hemlock bears N.7°W., 53.6 ft. with a healed double blaze
a 33" D. fir bears S.75°E. 79.3 ft. with a healed double blaze (Rec. S.70°E., 78.8ft.)
and a monument by Shrum in 1968:
a 1" (O.D.) iron pipe, firmly set, projecting 30" above the ground with a 2 1/2" aluminum cap stamped "T28S R2W C 1/4 S6 RE 4287 1968" bears N.8°30'W., 1.84 ft. (Rec. N.3°44'53"W., 1.93ft.)
and bearing trees by Shrum in 1968 :
a 53" D. fir bears N.32°W., 36.0 ft. with a healed blaze (Rec. N.32°W., 37.2 ft)
a 39" D. fir bears S.82°W., 41.8 ft. with a healed blaze (Rec. S.81°W., 42.5 ft)

Description of monument and accessories I established to perpetuate the original location:

I paint a 6" red band and BT faces red and nail USFS "BEARING TREE" and "LAND SURVEY MONUMENT" signs to all bearing trees:
Magnetic declination: 20°E.
