

AFFIDAVIT OF CORRECTION

I, Mark A. Heimburger, being duly sworn, depose and say that I am the surveyor who surveyed the property as depicted, filed and recorded in C.S. M137-59A Douglas County, Oregon Survey Records: and the following corrections to said plat are necessary and are as follows:

1. The distance along the property line common with the north northerly right-of-way of Kester Road is changed from 708.62' to 707.97'.
2. The remaining distance along the north line of Kester Road is changed from 780.24' to 780.89'.
3. The bearing and distance of from the bent 5/8 inch iron rod on the northerly right-of-way of Kester Road is changed from N36°05'E 0.32' to N70°47'W 0.89'.
4. The bearing and distance along the West line of Section 15, Township 27 South, Range 5 West, Willamette Meridian is changed from N01°42'35"E 2220.68' to N01°44'06"E 2220.85'.
5. The distance from the Section Corner common to Sections 9, 10, 15 & 16, Township 27 South, Range 5 West, N 87°58'48" W is changed from 506.95' to 508.58'.
6. The distance N00°34'25"E from the calculated point from which the 5/8 inch iron rod bears N32°17'E 3.11' is changed from 805.70' to 805.64'.
