

AFFIDAVIT OF CORRECTION

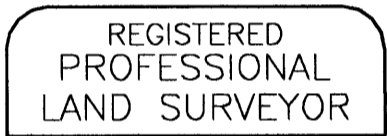

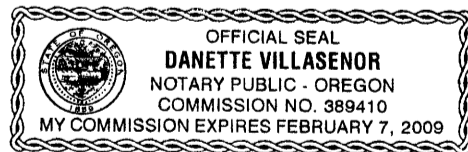
