AFFIDAVIT OF CORRECTION

I, Mark A. Heimburger, being duly sworn, depose and say that I am the surveyor who surveyed the Subdivision Plat of "Hunter's Crossing, 1st Addition as filed and recorded in Volume 20, Page 46B, Douglas County, Oregon Plat Records; and

The following correction to said plat is necessary and is as follows:

1. Show found monument symbols at the Southwest corner of Lot 2, 3, 4, 5 & 6 Hunters Crossing, Volume 20, Page 17.
2. Add distances of 10.34' between the found monument at the Southwest corner of Lot 2, Hunters Crossing and the set monument at the Northeast corner of Lot 40, Hunters Crossing, 1st Addition.
3. Add distances of 8.28' between the found monument at the Southwest corner of Lot 3, Hunters Crossing and the set monument at the Northeast corner of Lot 39, Hunters Crossing, 1st Addition.
4. Add distances of 6.21' between the found monument at the Southwest corner of Lot 4, Hunters Crossing and the set monument at the Northeast corner of Lot 38, Hunters Crossing, 1st Addition.

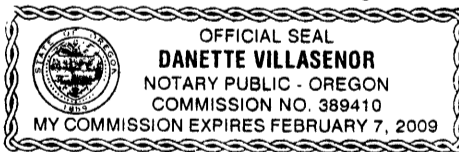
