AN ORDINANCE VACATING THE UNNAMED ALLEYWAY BETWEEN LOTS 12 AND 13, BLOCK 22, OF THE ORIGINAL TOWN OF RIDDLE, DOUGLAS COUNTY, OREGON.

WHEREAS:

A. ORS Chapter 271 provides for vacation of streets and alleyways upon the council's motion.

B. The council, by resolution dated March 9, 1998, determined that a certain unnamed, dedicated alleyway between Lots 12 and 13, Block 22, of the Original Town of Riddle, Douglas County, Oregon, should be vacated as the alleyway is not used or open to the public and vacation of said alleyway would benefit adjacent property.

C. By the resolution of March 9, 1998, the council established April 13, 1998, as the time for hearing on the proposed vacation with hearing to be held at council chambers, city hall, Riddle, Oregon.

D. By affidavit of posting, the city recorder has certified that posting of a notice of street vacation has been made as required by law.

E. A consent to vacation of alleyway has been signed by the property owner(s) adjacent to the alleyway and the consent to vacation of alleyway has been filed with the city recorder.

F. The council met at the appointed time and place for hearing and no objections or remonstrances were filed with the common council.

THE CITY OF RIDDLE ORDAINS AS FOLLOWS:

SECTION 1. The following platted alleyway is vacated: The unnamed, dedicated alleyway between Lots 12 and 13, Block 22, of the Original Town of Riddle, Douglas County, Oregon.

SECTION 2. The city recorder shall file a certified copy of this ordinance, pursuant to ORS Chapter 271, with the County Clerk, Assessor and Surveyor of Douglas County, Oregon.

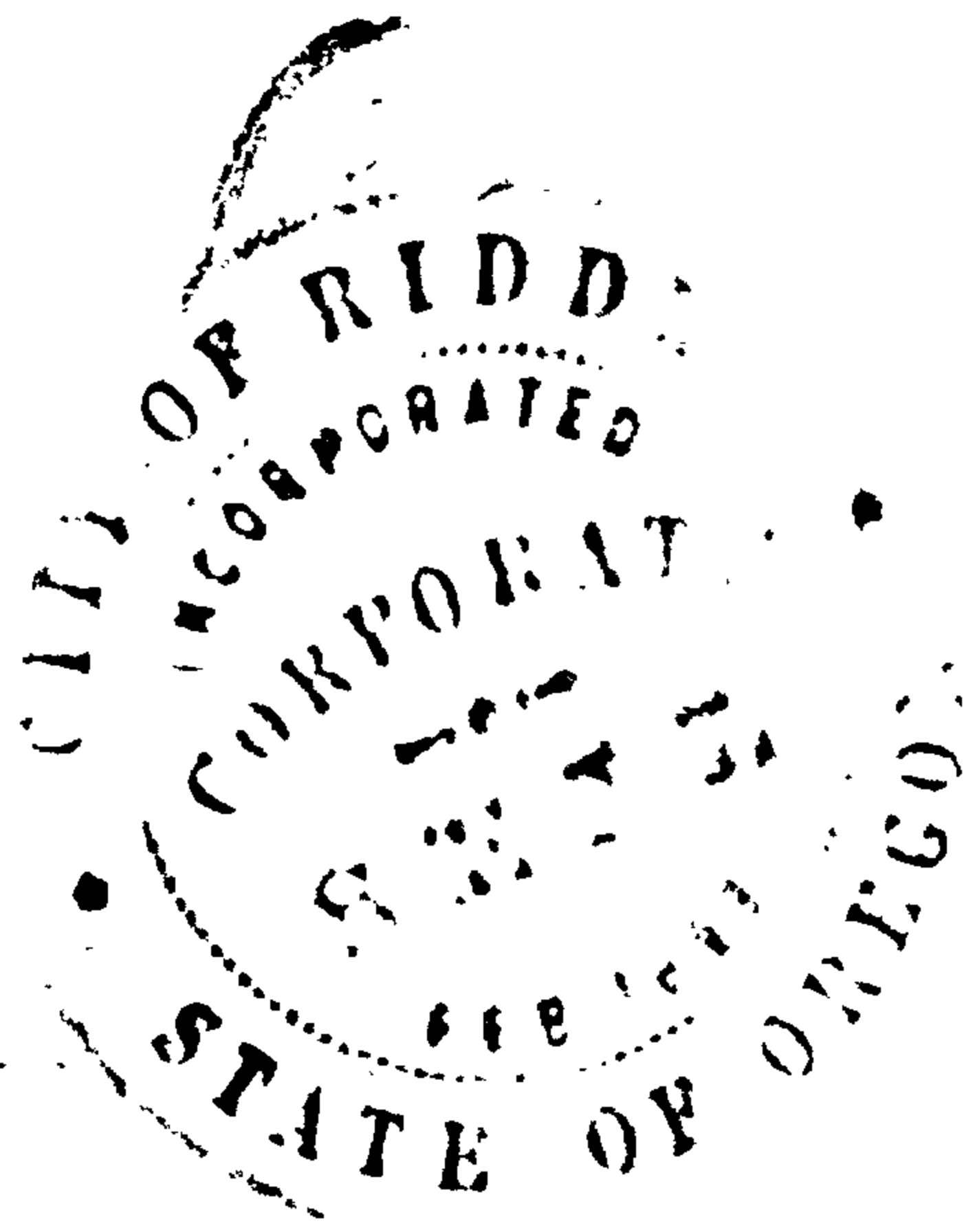

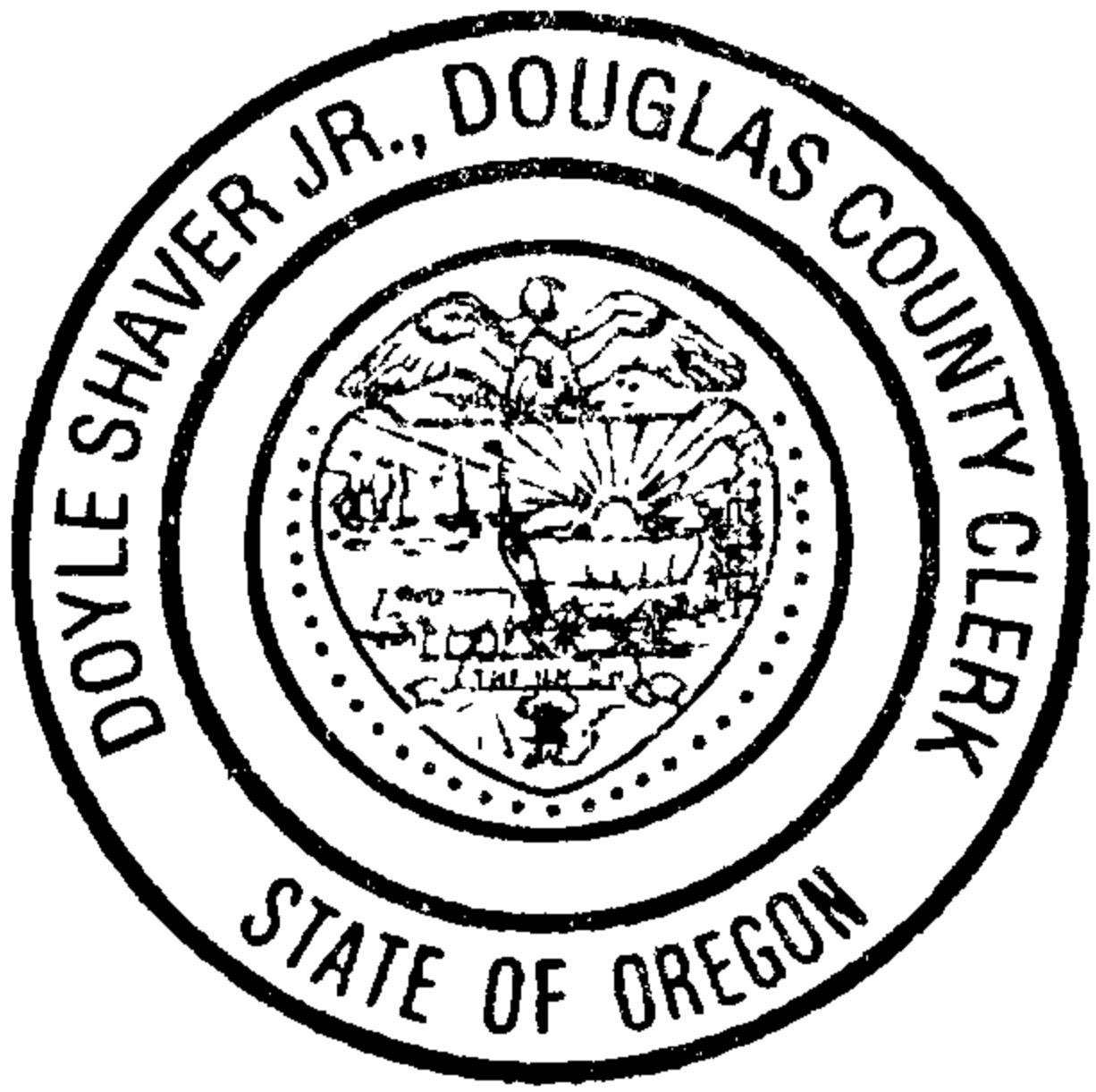
