ORDER GRANTING VACATION
OF INTERNAL LOT LINES

This matter comes before the Board of Commissioners upon petition of Glide School District No. 12 for vacation of internal lot lines described in "Exhibit A."

All the owners of the subject property have signed the petition.

The Planning Department found that the vacation of interior lot lines complies with applicable land use regulations and facilitates development of the subject property.

The Board of Commissioners hereby finds that the lot line vacation is in the public interest, benefits property utilization and should be approved.

IT IS HEREBY ORDERED that the interior lot line described in "Exhibit A" is vacated, except that any existing utilities or owners of drainage facilities located within the property will have continued and unrestricted access to service, maintain, upgrade or replace their facilities, and the County Clerk is authorized and directed to record this order in the Deed records of Douglas County, Oregon.

Copies of this order shall also be filed with the County Surveyor and County Assessor.

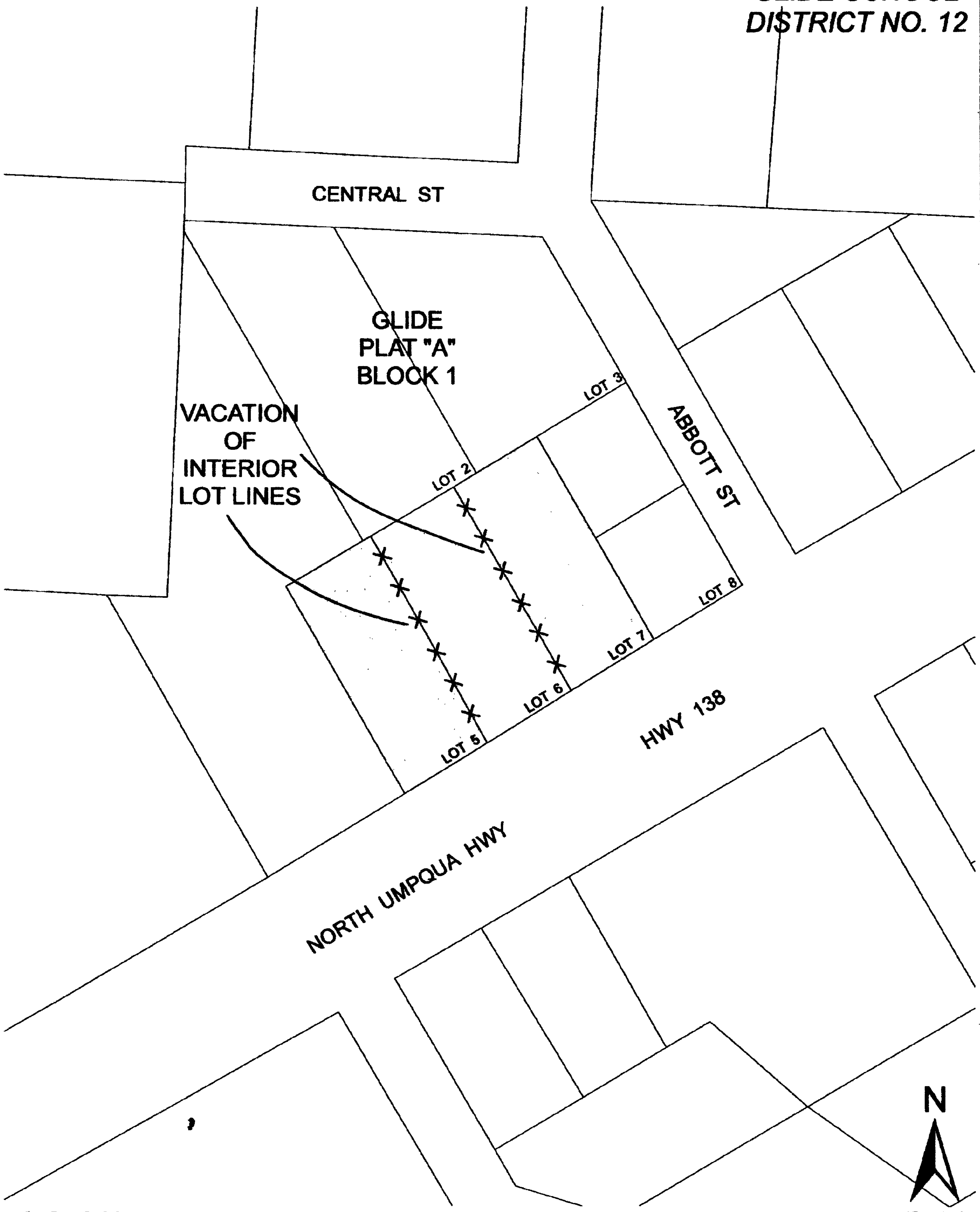

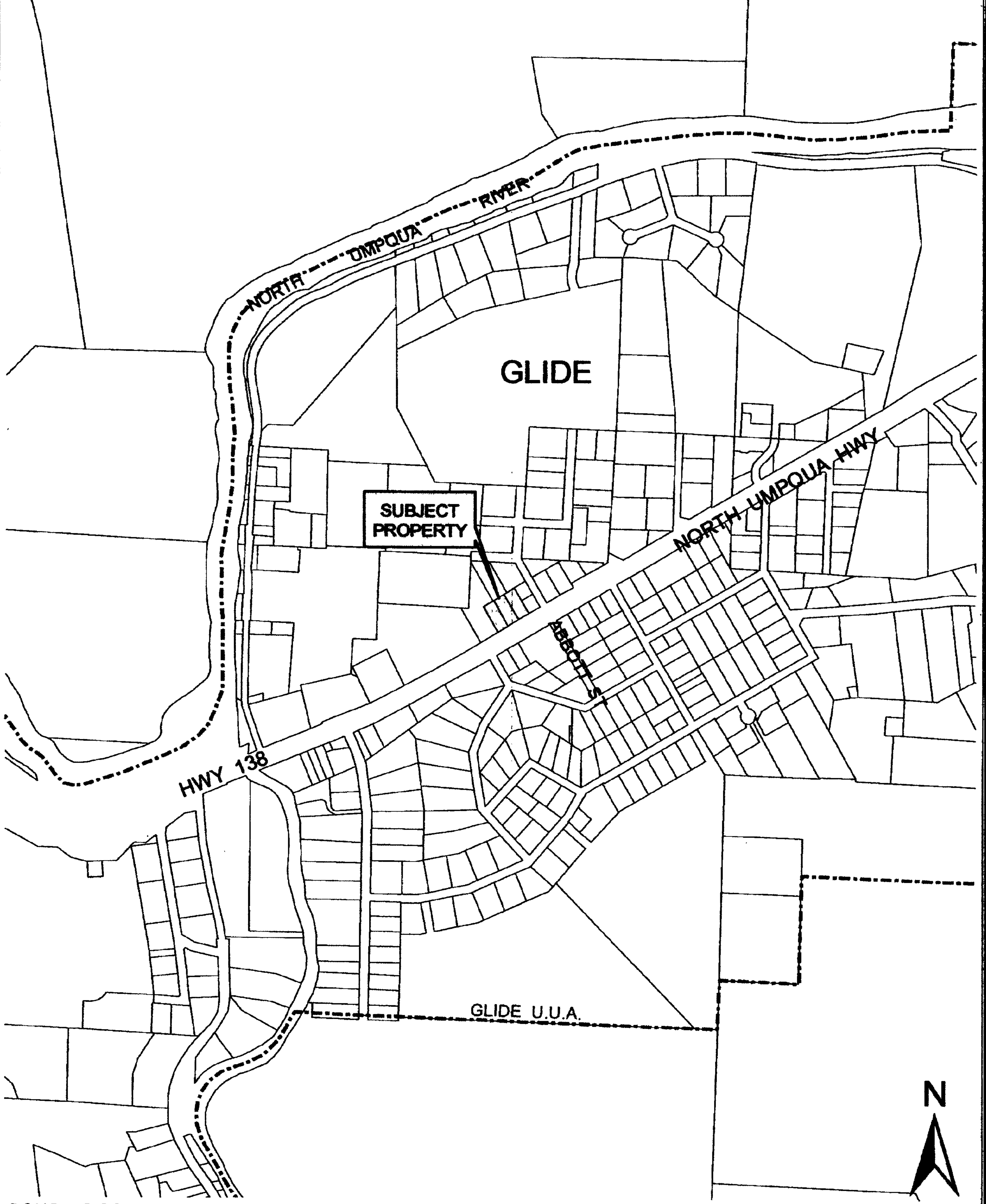
