This matter comes before the Board of Commissioners on a resolution for vacation of the public square described in the attached Exhibit "A".

The County Road Official has filed a written report with the Board pursuant to ORS 368.346. After a hearing on the proposed vacation, the Board of Commissioners has determined that it is in the public interest to vacate the public square.

NOW, THEREFORE, IT IS HEREBY ORDERED that the public square described in this order is vacated, except that any existing utilities or owners of drainage facilities located within said property will have unrestricted access to service, maintain, upgrade or replace their facilities. Title to the vacated property will vest in the Scottsburg Community Service Association.
