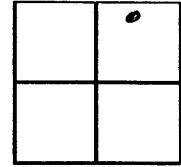

DESCRIPTION AND TO REACH

STATION DESCRIPTION

DESCRIBED BY DOUGLAS COUNTY OREGON 1998 (RWS)
THE STATION IS LOCATED ABOUT 3.5 KM (2.15 MI) NORTHWEST OF THE CENTER OF ROSEBURG, IN THE FRONT YARD OF A PRIVATE RESIDENCE OWNED BY THE DOUGLAS COUNTY SURVEYOR, IN SECTION 10, TOWNSHIP 27 SOUTH, RANGE 6 WEST. OWNERSHIP--ROMEY WARE, 204 DARLEY DRIVE, ROSEBURG, OR 97470. PHONE 541-440-4272 (WORK), 541-672-8210 (HOME). TO REACH THE STATION FROM THE INTERSECTION OF INTERSTATE HIGHWAY 5 AND GARDEN VALLEY ROAD (EXIT 125) IN ROSEBURG, GO WESTERLY ON GARDEN VALLEY DRIVE FOR 3.38 KM (2.10 MI) TO THE INTERSECTION OF MELROSE ROAD ON THE LEFT AND DARLEY DRIVE ON THE RIGHT. TURN RIGHT, NORTHEAST, ON DARLEY DRIVE FOR 0.08 KM (0.05 MI) TO THE SECOND PRIVATE DRIVEWAY ON THE LEFT. TURN LEFT, NORTH, ONTO PAVED DRIVEWAY FOR 61 M (200.1 FT) TO THE JUNCTION OF ANOTHER DRIVEWAY ON THE RIGHT. TURN RIGHT, EASTERLY, ON PAVED DRIVEWAY FOR 61 M (200.1 FT) TO THE STATION ON THE LEFT. THE STATION IS A DOUGLAS COUNTY SURVEYORS OFFICE DISK SET IN TOP OF A 30 CM DIAMETER AND 110 CM DEEP, BELLED CONCRETE MONUMENT DUG TO BEDROCK AND FLUSH WITH THE GROUND. IT IS 20 M (65.6 FT) WEST FROM THE EAST END OF A Y-JUNCTION IN THE DRIVEWAY, 3.6 M (11.8 FT) SOUTHWEST OF REFERENCE MARK NUMBER 1, 1.4 M (4.6 FT) SOUTH FROM A WITNESS POST IN THE FENCE, AND 0.6 M (2.0 FT) NORTH OF THE EDGE OF THE PAVED DRIVEWAY.
