4. The requirements of Douglas County Code, Chapter 17.12 have been met.


The territory described on the attached **Exhibit A** is declared to be annexed to the Douglas County Livestock District.


The County Clerk is directed to give notice of this annexation as provided in Douglas County Code, Section 17.12.110.

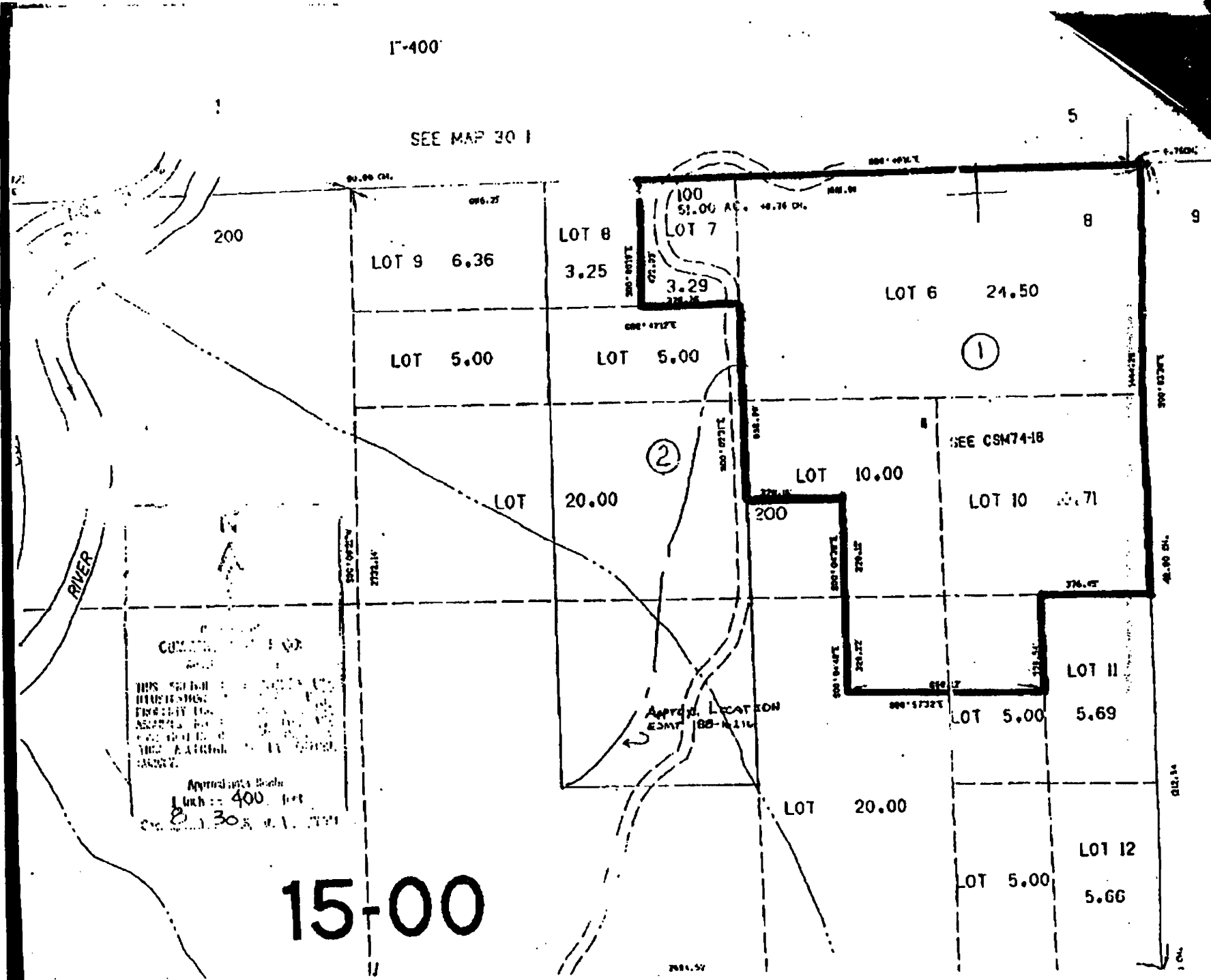
