EXHIBIT "A"

BOUNDARIES OF THOMPSON LIVESTOCK DISTRICT

Beginning on the North Boundary of an existing livestock district and on the line between Section 7 and 18 Township 30 South, Range 6 West, Willamette Meridian; where said line passes through the corner common to Sections 7, 8, 17 and 18, said township and range; thence West along the section lines to the corner common to Sections 10, 11, 14 and 15, Township 30 South, Range 7 West; thence North along the section lines to the 1/4 corner common to Sections 10 and 11; thence West to the center of Section 10; thence North to the 1/4 corner common to Sections 3 and 10; thence East to the corner common to Sections 2, 3, 10, and 11, Township 30 South, Range 7 West; thence North along the section lines to the corner common to Sections 26, 26 1/2, 34 1/2 and 35, Township 29 South, Range 7 West; thence East along the section lines to the South 1/4 corner of Section 30, Township 29 South, Range 6 West; thence North to the N.W. corner of the S.W. 1/4 of the S.E. 1/4 of said Section 30; thence East to the N.E. corner of the S.W. 1/4 of the S.E. 1/4 of said Section 30; thence South to the S.E. corner of the S.W. 1/4 of the S.E. 1/4 of said Section 30; thence East along the section lines to the corner common to Sections 28, 29, 32 and 33, Township 29 South, Range 6 West; thence North along the section line to the N.E. corner of the S.E. 1/4 of the S.E. 1/4 of Section 29; thence West to the S.W. corner of the N.W. 1/4 of the S.E. 1/4 of Section 29; thence North to the 1/4 corner common to Sections 20 and 29, Township 29 South, Range 6 West; thence East along the Section lines to the N.E. corner of the N.W. 1/4 of the N.W. 1/4 of Section 27; thence South to the S.E. corner of S.W. 1/4 of the N.W. 1/4 of Section 27; thence West to the 1/4 corner common to Sections 27 and 28; thence South to the corner common to Sections 27, 28, 33 and 34, Township 29 South, Range 6 West; thence East along the Section Line to the corner common to Sections 26, 27, 34 and 35 same Township and Range as above; thence South along the section lines to the corner common to Sections 2, 3, 10 and 11, Township 30 South, Range 6 West; the sections hereinafter mentioned lie in Township 30 South, Range 6, West, W.M.; thence West along the section line to the corner common to Sections 3, 4, 9 and 10; thence South to the 1/4 corner common to Sections 9 and 10; thence West to the center of Section 8; thence North to the 1/4 corner common to Sections 5 and 8; thence West to the corner common to Sections 5, 6, 7 and 8; thence South along the section line to the point of beginning.
