DEED DESCRIPTION PREPARED FOR:  
DOUGLAS COUNTY BOARD OF COMMISSIONERS  
(Nonpareil Livestock District)

Beginning at the Northwest corner of Section 7 in Township 25 South, Range 4 West of the Willamette Meridian: Running thence Easterly to the Southwest corner of Section 3 in said Township and Range; thence Northerly to the Northwest corner of said Section 3; thence Easterly to the Southwest corner of Section 36 in Township 24 South, Range 4 West; thence Northerly to the Northwest corner of said Section 36; thence Easterly to the Northwest corner of Section 32 in Township 24 South, Range 3 West; thence Northerly to the Northwest corner of Section 17 in said Township and Range; thence Easterly to the Northeast corner of Section 15 in said Township and Range; thence Southerly to the Southeast corner of Section 22 in said Township & Range; thence Westerly to the Southwest corner of said Section 22; thence Northerly to the Southeast corner of the North half of the South half of Section 21 in said Township and Range; thence Westerly to the East line of Section 20 in said Township and Range; thence Southerly to the Southeast corner of Section 32 in said Township and Range; thence Westerly to Calapooya Creek; thence Southwesterly along said Calapooya Creek to the South line of the Northwest quarter of the Northeast quarter of Section 10 in Township 25 South, Range 4 West; thence Southeasterly to the Southeast corner of the Southwest quarter of the Northeast quarter of said Section 10; thence Easterly to the Northeast corner of the Northwest quarter of the Southwest quarter of Section 11 in Township 25 South, Range 4 West; thence Southerly to the Northeast corner of the Southwest quarter of the Southwest quarter of said Section 11; thence Easterly to the Northeast corner of the Southeast quarter of the Southwest quarter of said Section 11; thence Southerly to the Northwest corner of the Northwest quarter of the Northeast quarter of Section 14, Township 25 South, Range 4 West; thence Easterly to a point on the North line of Section 14 in Township 25 South, Range 4 West, from which the Northeast corner of said Section 14 bears East 1031.2 feet; thence along the boundary of that property described in Book 452 Page 343 of the Deed Records of Douglas County, Oregon South 39° 44' West 642.6 feet to an iron pipe; thence along said boundary South 3° 35' West 642.6 feet to an iron pipe; thence along said boundary South 31° 30' West 215 feet, more or less, to an iron pipe and the intersection with the North line of the South half of the Northeast quarter of said Section 14; thence along said boundary South 31° 30' West 382.7 feet to an iron pipe; thence along said boundary South 46° 49' West 460.7 feet to an iron pipe; thence along said boundary South 32° 33' West 377.5 feet to an iron pipe; thence along said boundary South 17° 40' West 431.6 feet, more or less, to the intersection with the South line of the North

half of said Section 14; thence Westerly to the Southwest corner of the Northwest quarter of said Section 14; thence Northerly to the Southeast corner of Section 10 in Township 25 South, Range 4 West; thence Westerly to the Southwest corner of said Section 10; thence Southerly to the Southeast corner of Section 16 in said Township and Range; thence Westerly to the Southwest corner of Section 18 in said Township and Range; thence Northerly to the point of beginning, all in Douglas County, Oregon and containing 12,800 acres, more or less.
