The Petition of Laugen, White, Whitney, et al, for annexation of territory to the Thompson Creek Livestock District, Douglas County, Oregon, having been filed heretofore with the Board of Commissioners of Douglas County, Oregon, on the 26th day of August, 1981; and

IT APPEARING to the Board of Commissioners of Douglas County, Oregon, that the Petition for Annexation of the territory hereinafter described was signed and acknowledged by the owners of all of the land included within said territory; and

IT FURTHER APPEARING that a hearing was held at the Douglas County Courthouse on the 30th day of September 1981, at the hour of 10:00 a.m.m on the matter of the proposed annexation of the land hereinafter described and no objections having been made to the Petition for Annexation; and

IT FURTHER APPEARING to the Board that a Petition was duly filed with said Commissioners for the annexation of all hereinafter described lands, which Petition complies in all respects with the requirements of ORS 607.005 to 607.051;

NOW THEREFORE, the Board of Commissioners of Douglas County, Oregon, does hereby approve said Petition for Annexation and does hereby proclaim and declare the land and properties of Petitioners more particularly described in Exhibit "A", attached to this Order and by this reference incorporated herein in full, as hereby being duly and regularly incorporated within, included within and annexed to THOMPSON CREEK LIVESTOCK DISTRICT, Douglas County, Oregon, in like manner as other territory within said District.
