PARCEL #1

A parcel of land lying in Section 8, Township 30 South, Range 5 West, Willamette Meridian and being a portion of Lot 3 of "MARCH PLAT A" as recorded in Volume 7, Page 43 in the Plat Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 5/8" iron rod in the easterly line of Valley Street from which point the Southeast Corner of the above said Lot 3 bears South 55° 06' 55" East 998.42 feet; thence along said easterly line North 26° 51' 39" East 171.16 feet to a 5/8" iron rod; thence leaving said easterly line South 73° 28' East 373.64 feet to a 5/8" iron rod; thence South 15° 12' 39" West 90.00 feet to a 5/8" iron rod; thence South 59° 58' East 316.90 feet to a 5/8" iron rod; thence South 5° 18' 15" West 190.83 feet to a 5/8" iron rod; thence North 59° 58' West 350.86 feet to a 5/8" iron rod; thence North 60° 05' West 69.88 feet to a 5/8" iron rod; thence North 15° 08' West 51.88 feet to a 5/8" iron rod; thence North 66° 08' 55" West 317.91 feet to the point of beginning and containing 3.17 acres of land, more or less.

PARCEL #2

A parcel of land lying in Section 8, Township 30 South, Range 5 West, Willamette Meridian and being a portion of Lots 2 and 3 of "MARCH PLAT A" as recorded in Volume 7, Page 43 in the Plat Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 3/4" iron pipe at the most westerly corner of the above said Lot 3; thence along the easterly line of Valley Street North 26° 51' 39" East 60.00 feet to a 5/8" iron rod; thence leaving said easterly line South 66° 08' 55" East 317.91 feet to a 5/8" iron rod; thence South 15° 08' East 51.88 feet to a 5/8" iron rod; thence South 60° 05' East 69.88 feet to a 5/8" iron rod; thence South 59° 58' East 350.86 feet to a 5/8" iron rod; thence North 5° 18' 15" East 190.83 feet to a 5/8" iron rod; thence North 59° 58' West 316.90 feet to a 5/8" iron rod; thence North 15° 12' 39" East 90.00 feet to a 5/8" iron rod; thence North 73° 28' West 373.64 feet to a 5/8" iron rod in the above said easterly line of Valley Street; thence along said easterly line North 26° 51' 39" East 206.86 feet to a 1 1/2" iron pipe and along the arc of a 1181.56 foot radius curve to the left (the long chord of which bears North 24° 24' 22" East 96.02 feet) 96.05 feet to a 5/8" iron rod; thence leaving said easterly line along the arc of a 350 foot radius curve to the right (the long chord of which bears South 57° 54' 30" East 121.65 feet) 122.27 feet to a 5/8" iron rod; thence along the arc of a 564.68 foot radius curve to the left (the long chord of which bears South 55° 57' 49" East 158.42 feet) 158.94 feet to a 5/8" iron rod; thence South 64° 01' 38" East 227.22 feet to a 5/8" iron rod; thence along the arc of a 426.35 foot radius curve to the left (the long chord of which bears South 76° 35' 18" East 185.45 feet) 186.95 feet to a 5/8" iron rod in the East Line of the above said Lot 3; thence along said East Line South 0° 50' 57" West 700.00 feet to a 3/4" iron pipe; thence along the southerly line of said Lot 3 North 58° 33' West 991.94 feet to the point of beginning and containing 7.45 acres of land, more or less.

PARCEL #3

A parcel of land lying in Section 8, Township 30 South, Range 5 West, Willamette Meridian and being a portion of Lots 2 and 3 of "MARCH PLAT A" as recorded in Volume 7, Page 43 in the Plat Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 3/4" iron pipe at the Northwest Corner of the above said Lot 2; thence along the North Line of said Lot 2 South 88° 31' 37" East 555.38 feet to a 5/8" iron rod; thence along the East Line of said Lot 2 and the above said Lot 3, respectively, South 0° 50' 57" West 539.10 feet to a 5/8" iron rod; thence along the arc of a 426.35 foot radius curve to the right (the long chord of which bears North 76° 35' 18" West 185.45 feet) 186.95 feet to a 5/8" iron rod; thence North 64° 01' 38" West 227.22 feet to a 5/8" iron rod; thence along the arc of a 564.68 foot radius curve to the right (the long chord of which bears North 55° 57' 49" West 158.42 feet) 158.94 feet to a 5/8" iron rod; thence along the arc of a 350.00 foot radius curve to the left (the long chord of which bears North 57° 54' 30" West 121.65 feet) 122.27 feet to a 5/8" iron rod in the easterly line of Valley Street; thence along said easterly line along the arc of a 1181.56 foot radius curve to the left (the long chord of which bears North 15° 34' 56" East 267.31 feet) 267.88 feet to the point of beginning and containing 5.90 acres of land, more or less.

Excepting therefrom the southerly 28 feet.
