LEGAL DESCRIPTION FOR DONNA DANILLE PECKHAM:

The following describes a 161.81 acre parcel, lying in the West 1/2 of Section 15 and the East 1/2 of Section 16, Township 28 South, Range 5 West, Willamette Meridian, Douglas County, Oregon and containing 2 lots, Lot 1 being 75.04 acres and Lot 2 being 88.54 acres. The perimeter of both is described as follows:
