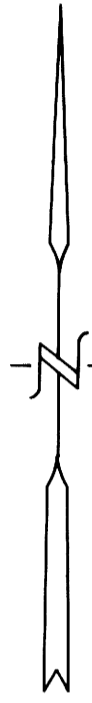

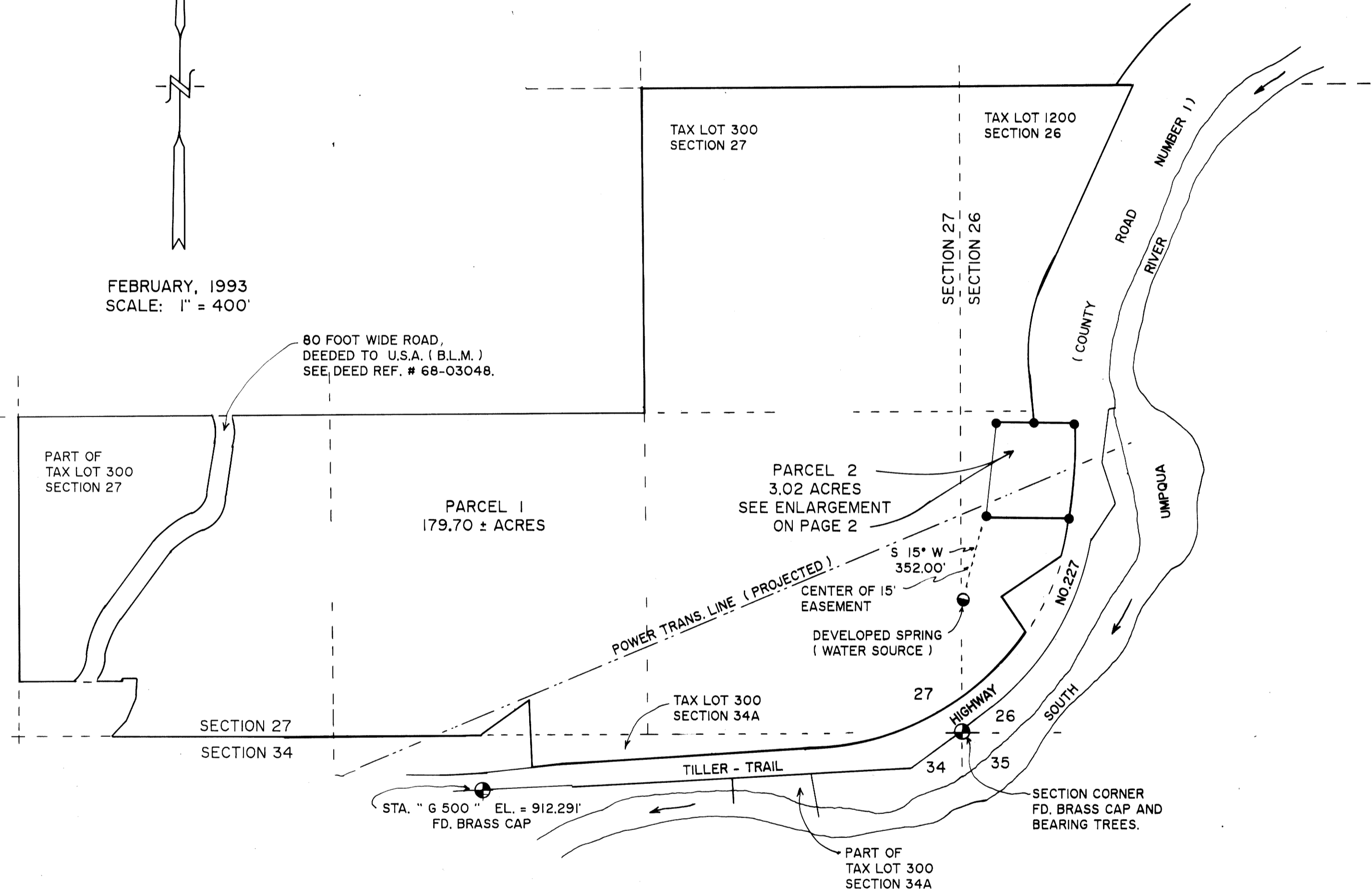

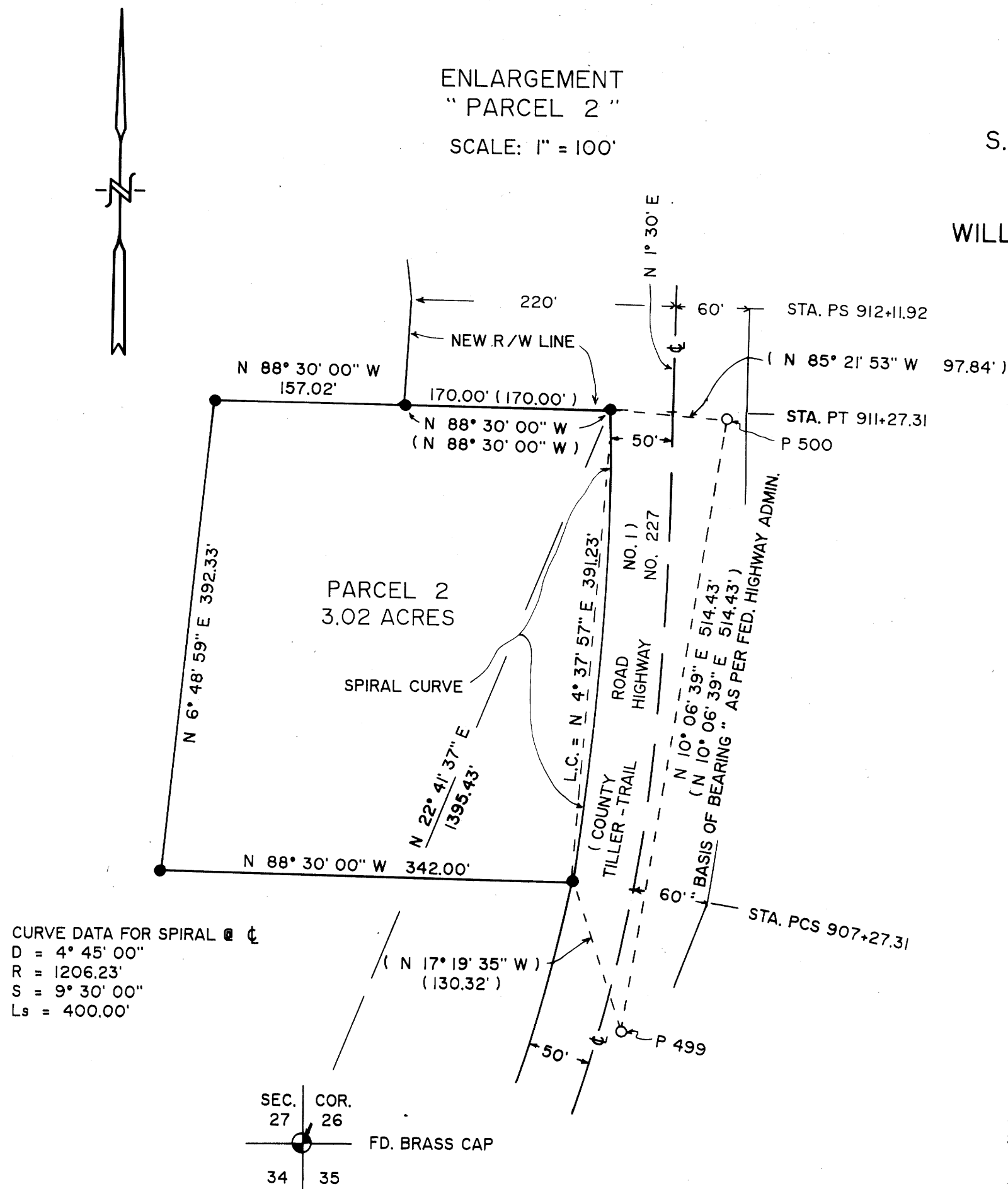

NARRATIVE:

THE PURPOSE OF THE SURVEY WAS TO CREATE A 3 ACRE PARCEL FROM THE 182.70 ACRE PARCEL AS SHOWN. FIELD INVESTIGATION LOCATED THE SAID FOUND CORNERS AND CONDITIONS. CONTROL FOR THE SURVEY WAS THE NEW RIGHT OF WAY BOUNDARY FOR COUNTY ROAD NUMBER 1 ON THE EASTERLY AND NORTHERLY BOUNDARIES. THE DESIRED ACREAGE CONTROLLED THE PLACEMENT OF THE OTHER SET CORNERS. THE PLACEMENT OF THE RIGHT OF WAY CORNERS AS SHOWN WERE DEFINED BY THE FEDERAL HIGHWAY ADMINISTRATION. I ALSO USED THE FEDERAL HIGHWAY ADMINISTRATION'S PRIMARY CONTROL POINTS TO SET THE SAID RIGHT OF WAY CORNERS. ALL DATA FOR THESE RIGHT OF WAY CORNERS AND PRIMARY CONTROL POINTS WERE SUPPLIED TO ME BY THE FEDERAL HIGHWAY ADMINISTRATION, WITH THEIR RECORD BEARING BETWEEN THE TWO PRIMARY CONTROL POINTS SHOWN, USED AS MY " BASIS OF BEARING "

SEE REFERENCE NUMBER 91-03600, DOUGLAS COUNTY DEED OF RECORDS, LESS PARCEL 2, DESCRIBED BELOW.

PARCEL 2

BEGINNING AT A 5/8 INCH IRON ROD LOCATED ON THE WESTERLY RIGHT OF WAY OF DOUGLAS COUNTY ROAD NUMBER 1 (RELOCATED), SAID 5/8 INCH IRON ROD BEARS NORTH 22° 41' 37" EAST 1395.43 FEET FROM THE SECTION CORNER COMMON TO SECTIONS 26, 27, 34, & 35, TOWNSHIP 30 SOUTH, RANGE 3 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON; THENCE ALONG SAID WESTERLY RIGHT OF WAY OF DOUGLAS COUNTY ROAD NUMBER 1 (RELOCATED), ALONG THE ARC OF A 400 FOOT SPIRAL CURVE TO THE RIGHT, THE LONG CHORD OF WHICH BEARS SOUTH 4° 37' 57" WEST 391.23 FEET TO A 5/8 INCH IRON ROD; THENCE LEAVING SAID WESTERLY RIGHT OF WAY AND RUNNING NORTH 88° 30' 00" WEST 342.00 FEET TO A 5/8 INCH IRON ROD; THENCE NORTH 6° 48' 59" EAST 392.33 FEET TO A 5/8 INCH IRON ROD; THENCE SOUTH 88° 30' 00" EAST 327.02 FEET TO THE POINT OF BEGINNING.

TOGETHER WITH AN 15 FOOT WIDE WATER LINE EASEMENT FROM THE EXISTING SPRING LOCATED ON PARCEL 1.
