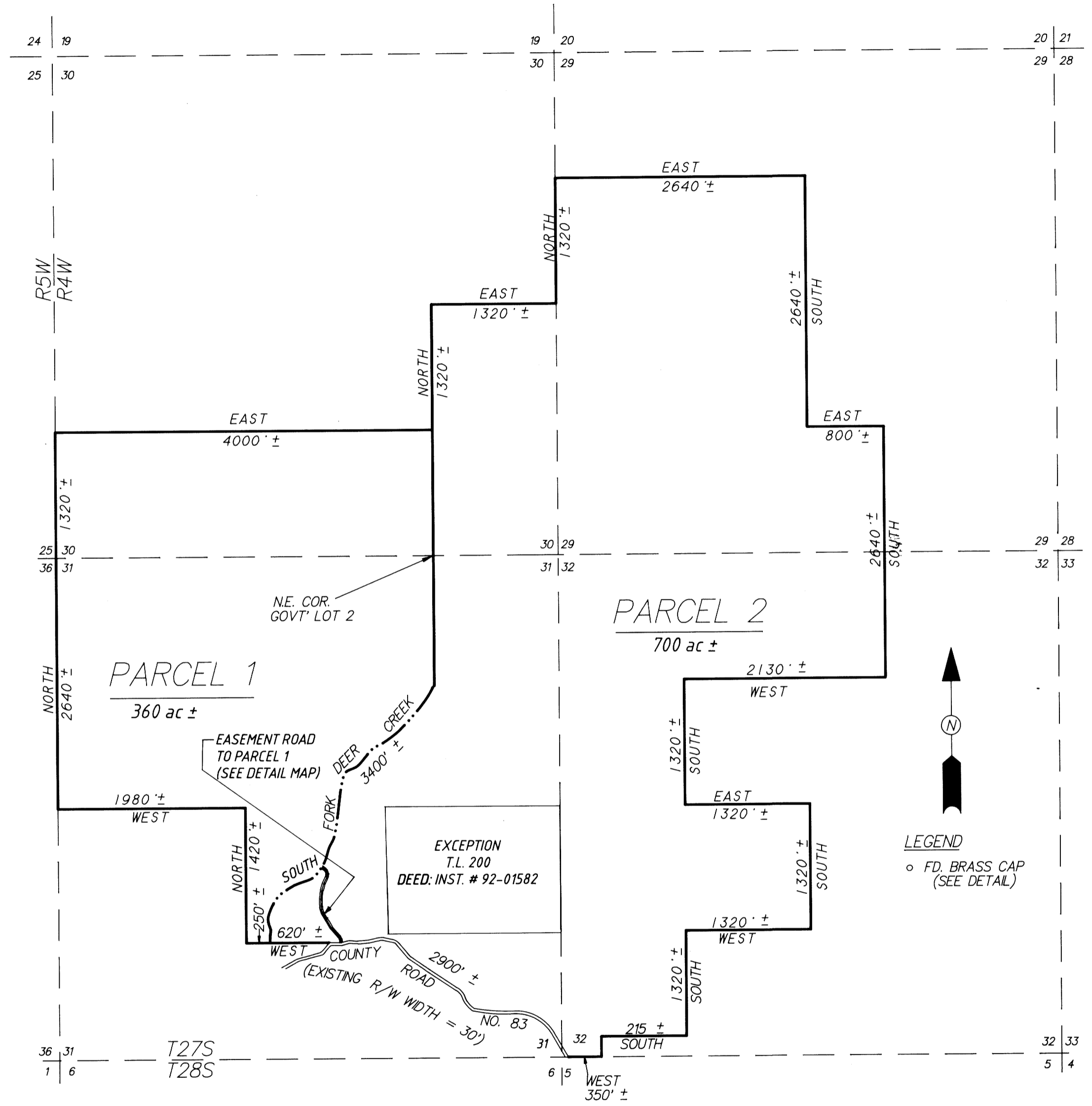
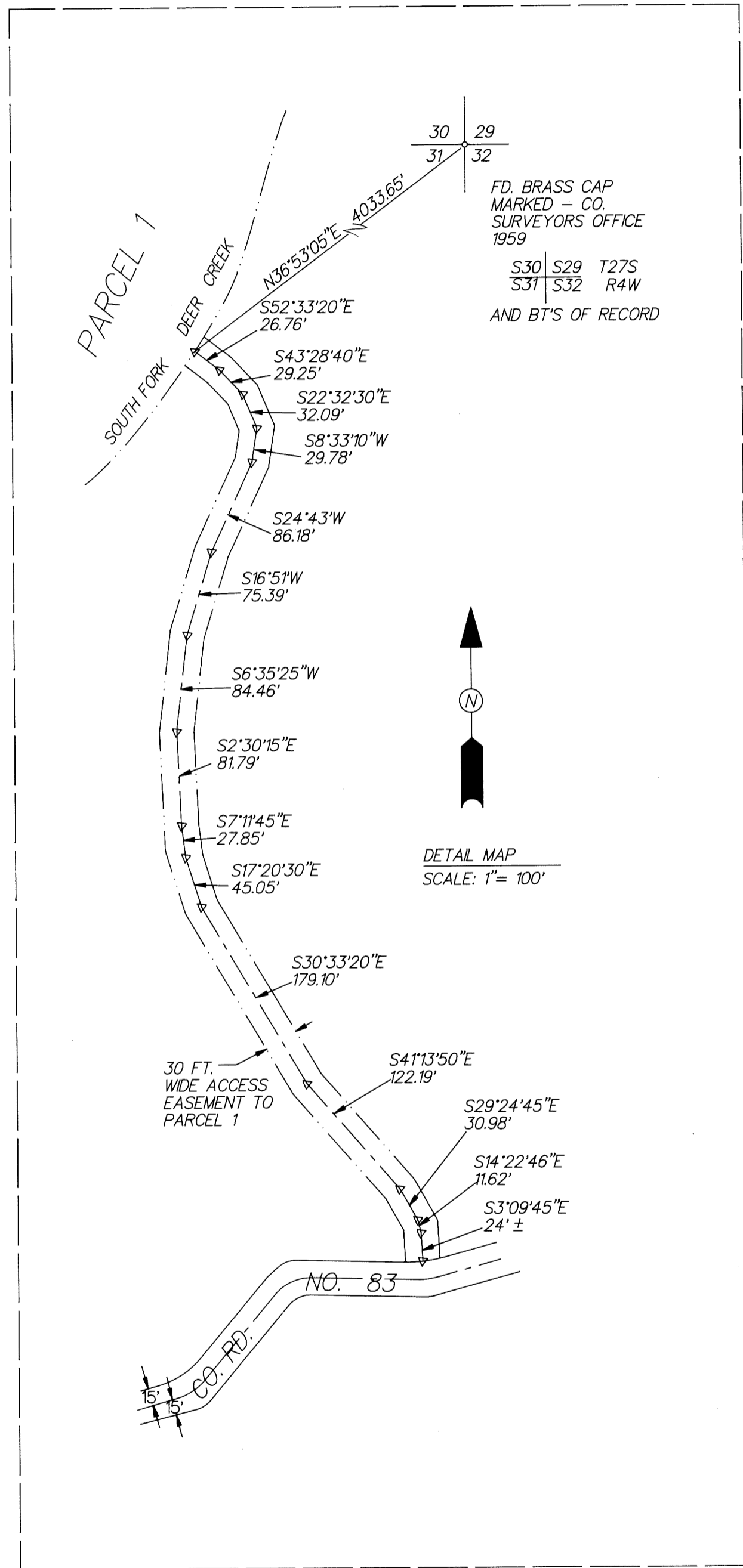

DESCRIPTION:

A PORTION OF THAT PROPERTY DESCRIBED IN INSTRUMENT NO. 84-2636 AS RECORDED IN THE DEED RECORDS OF DOUGLAS COUNTY, OREGON, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WEST LINE OF THE JOSEPH C. DURBIN D.L.C. NO. 50 IN SECTION 31, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN, 16.20 CHAINS SOUTH OF THE NORTHWEST CORNER OF SAID D.L.C. NO. 50, SAID POINT OF BEGINNING BEING ALSO THE SOUTHWEST CORNER OF A TRACT OF LAND DEEDED BY THOMAS W. HATFIELD TO CLYDE B. HATFIELD BY DEED DATED DECEMBER 14, 1914: RUNNING THENCE SOUTH ALONG WEST LINE OF SAID D.L.C. NO. 50 TO THE SOUTHWEST CORNER THEREOF; THENCE EAST ALONG THE SOUTH LINE OF SAID D.L.C. NO. 50 TO THE SOUTHEAST CORNER THEREOF; THENCE NORTH ALONG THE EAST LINE OF SAID D.L.C. NO. 50 TO A POINT OPPOSITE THE PLACE OF BEGINNING, INTERSECTING THE SOUTH LINE OF CLYDE B. HATFIELDS SAID LAND; THENCE WEST ALONG SAID LINE TO THE PLACE OF BEGINNING.

SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER, GOV'T LOT 3, SOUTH HALF OF THE NORTHWEST QUARTER, NORTH HALF OF THE SOUTHWEST QUARTER, SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER, ALL IN SECTION 29, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN.

SOUTH HALF OF THE SOUTHWEST QUARTER, THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER, AND THE SOUTH HALF OF THE SOUTHEAST QUARTER, ALL IN SECTION 30, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN.

GOV'T LOTS 2, 3, 4, 9, AND 10, THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER, THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER, AND THAT PORTION OF GOV'T LOT 7 AND THE SOUTH HALF OF THE SOUTHEAST QUARTER LYING NORTH OF COUNTY ROAD NO. 83, ALL IN SECTION 31, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN.

BEGINNING AT THE NORTHWEST CORNER OF GOV'T LOT 10, SECTION 31, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN; THENCE EAST TO THE SECTION LINE BETWEEN SECTIONS 31 AND 32; THENCE NORTH WITH SECTION LINE TO THE NORTHEAST CORNER OF SAID SECTION 31; THENCE WEST WITH SECTION LINE TO THE NORTHEAST CORNER OF GOV'T LOT 2 OF SAID SECTION; THENCE SOUTH TO NORTH BOUNDARY LINE OF OF D.L.C. NO. 50; THENCE WEST WITH SAID NORTH BOUNDARY LINE OF D.L.C. NO. 50 TO THE NORTHWEST CORNER THEREOF; THENCE SOUTH TO POINT WEST OF POINT OF BEGINNING; THENCE EAST TO POINT OF BEGINNING, ALL IN GOV'T LOT 1 AND D.L.C. NO. 50, SECTION 31, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN.

GOV'T LOT 1 AND THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 32, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN; ALSO THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER, THE NORTH HALF OF THE SOUTHWEST QUARTER, AND GOV'T LOT 7 OF SECTION 32, TOWNSHIP 27 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN.

NARRATIVE:

PLAT FOR THE PURPOSE OF PARTITIONING THAT PROPERTY DESCRIBED IN INSTRUMENT NO. 84-2636 AS RECORDED IN THE DEED RECORDS OF DOUGLAS COUNTY, OREGON, INTO TWO PARCELS. ONLY THE 30 FOOT WIDE ACCESS EASEMENT WAS SURVEYED AND THE NORTHEAST AND NORTHWEST CORNERS OF SECTION 31 WERE TIED. BASIS OF BEARING WAS DETERMINED BY INVERSING BETWEEN SAID NORTHEAST AND NORTHWEST CORNERS (N89°33'W - 5209.64 FEET) AND USING THE BEARING (N89°33'W) GIVEN PER G.L.O. NOTES. RECORD DISTANCE WAS GIVEN AS 80.40 CHAINS (5306.40 FEET). THE LOCATION OF THE SOUTH FORK OF DEER CREEK WAS SCALED FROM ASSESSOR MAPS AND AERIAL PHOTOS.
