The purpose of this survey was to partition the land described as Lots 10, 11 and 12, Block 20, of The City Of Glendale (Julia), as recorded in Volume 1, Page 9, of the Book Of Plats of Douglas County, in conformance with the preliminary as approved by the City of Glendale (see file number LP-1-94).

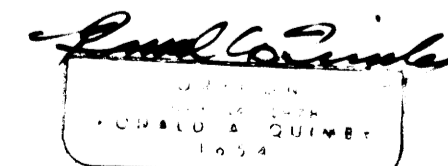
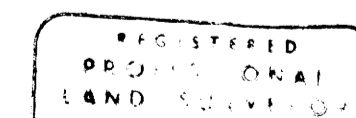
Based on the monuments found as shown and holding the monument at the southeast corner of Lot 12, Block 20, and the monument at the southeast corner of Lot 12, Block 21, established the northerly Right-Of-Way of Sol Abraham Avenue. The westerly Right-Of-Way of Second Street was established by holding said monument at the southeast corner of Lot 12, Block 20, and the monument set by Brandt at the southeast corner of that property shown in Survey M 77-5. The southerly Right-Of-Way line of Montgomery Street was established by holding the monuments found at the northwest corner of Lot 2, Block 19, set by Nygren and the 6' fence post set by Ruppert at the northeast corner of Lot 5, Block 21. The westerly Right-Of-Way of Third Street was established by holding the monument at the southeast corner of 12, Block 21, and proportioning the distance between said Nygren pin and said Ruppert fence post. The lots of Block 20 were then proportioned and the corners of Lots 10, 11 and 12 along with the corners of the newly created Parcels were set.
