THE SOUTHEASTERLY LINE WAS LOCATED ACCORDING TO FOUND MONUMENTS. THERE IS NO DIRECT RECORD FOR THE FOUND 3/4" IRON PIPES; HOWEVER THESE PIPES WERE ACCEPTED AS REPRESENTING THE LAND DESCRIBED BY DEED 90-01315.
