REPRESENTS A SURVEY MADE BY ME AND COMPLIES WITH REGULATIONS
FOR LAND PARTITIONS. THE FOLLOWING IS AN ACCURATE
DESCRIPTION OF THE PARENT TRACT OF LAND, AS SET FORTH HEREON:

MERIDIAN, DOUGLAS COUNTY, OREGON, BEING A 5/8" IRON ROD;
THENCE SOUTH 88°39'35" WEST, ALONG THE SOUTH LINE OF SAID
NORTHWEST QUARTER OF THE SOUTHEAST QUARTER, 1316.65 FEET TO
THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF THE
SOUTHWEST QUARTER OF SAID SECTION 6; THENCE WEST, ALONG THE
SOUTH LINE OF SAID NORTHEAST QUARTER OF THE SOUTHWEST
