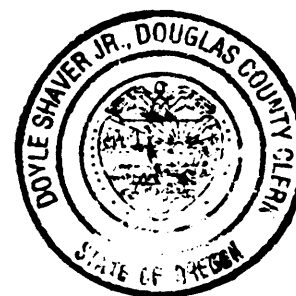
NARRATIVE:
