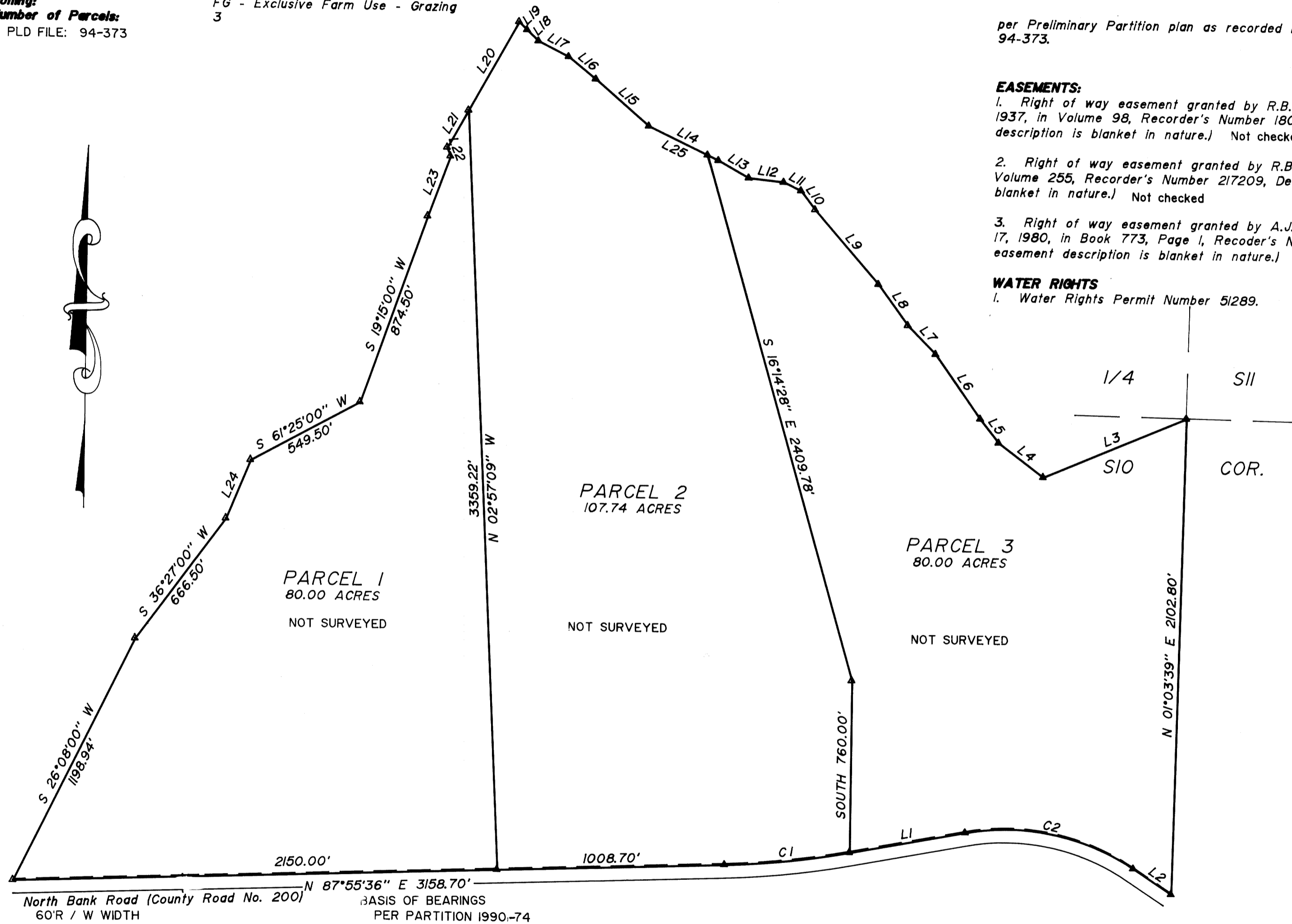

The subject property partitioned per Preliminary Partition plan as recorded in Douglas County Planning Department File Number 94-373.

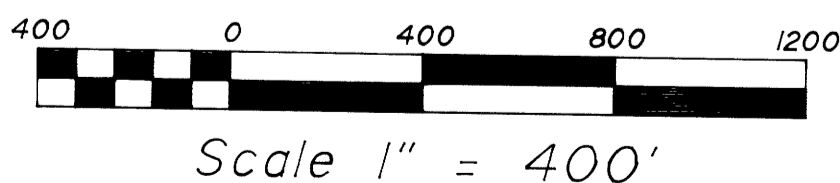
