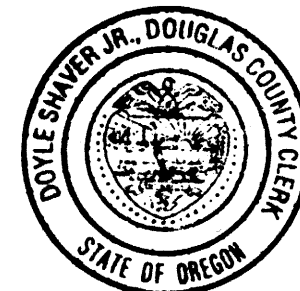

PROCEDURE:
THE MOST NORTHERLY CORNER OF LOT 16 WAS SET BY HOLDING THE ALIGNMENT OF THE NORTHWESTERLY LINE OF COOK STREET AND RECORD RIGHT-OF-WAY DISTANCES PER LP 1997-0105. THE SOUTHEASTERLY LINE OF COOK STREET WAS PROJECTED TO THE NORTHERLY LINE OF TRI-CITY TERRACE, FIRST ADDITION. THE RESULTING RIGHT-OF-WAY LINE ALONG LOTS 15 AND 16 WAS PROPORTIONED TO ORIGINAL DISTANCES PER AMENDED PLAT OF 4TH ADDITION TO BRIGGS ACRES.
