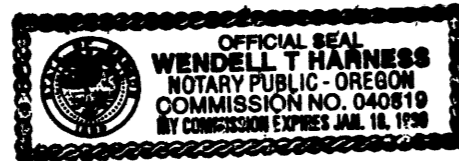

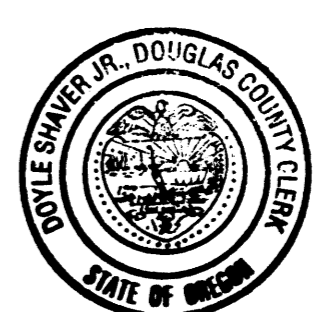

**NARRATIVE:**

THE PURPOSE OF THIS SURVEY IS TO PARTITION THAT PROPERTY DESCRIBED IN INSTRUMENT NO. 93-07671 INTO TWO PARCELS. POINTS [1] AND [2] WERE USED AS THE BASIS OF BEARING PER M57-15. POINT [2] WAS COMPUTED BY INTERSECTING THE WEST RIGHT-OF-WAY OF KESTER ROAD (BASED ON POINT [3] AND POINT [4]). POINT [4] WAS COMPUTED BY EXTENDING THE EAST LINE OF LOT 6 OF DEER CREEK ORCHARD TRACTS THE RECORD DISTANCE PER M57-34 USING FOUND MONUMENTS. POINT [5] WAS COMPUTED BY INTERSECTING THE EAST RIGHT-OF-WAY OF KESTER ROAD (HELD 64' EAST FROM THE BASIS OF BEARING LINE) WITH THE SOUTH RIGHT-OF-WAY OF KESTER ROAD. POINT [6] WAS COMPUTED BY INTERSECTING THE EAST RIGHT-OF-WAY OF KESTER ROAD WITH THE NORTH LINE OF PARCEL 1 OF M48-34 (USING FOUND MONUMENTS ALONG SAID NORTH LINE).
