

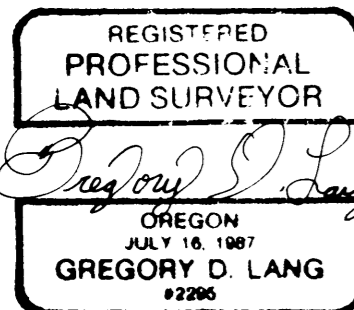

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO PARTITION THE PROPERTY DESCRIBED IN INSTRUMENT #98-21399 INTO 3 PARCELS & TO CREATE THE ACCESS & UTILITY EASEMENTS AS SHOWN.

THE GENERAL PATTERN OF LATER SURVEYS IN THIS AREA HAS BEEN TO ACCEPT WORK DONE BY PERCY ARMSTRONG IN THE 1950'S & USE RECORD DEED DISTANCES WHEN NO MONUMENTS FROM THE OLDER SURVEY WERE FOUND. IN PERFORMING THIS SURVEY, I FOUND THAT THE ABOVE MENTIONED "LATER SURVEYS" DID NOT RECOGNIZE OR UNCOVER ARMSTRONG'S MONUMENTS IN EVERY CASE. I NOTED THE POSITIONS OF ADDITIONAL MONUMENTS OF ARMSTRONG. HOWEVER, BASED ON THE EQUITABLE MEASUREMENTS SHOWN, I HAVE ACCEPTED AS CONTROLLING CORNERS THE CORNERS OF M53-62 & M78-20. THESE TWO SURVEYS PARTITIONED LAND ON EITHER SIDE OF THE SUBJECT PROPERTY DESCRIBED IN INSTRUMENT #98-21399.

COUNTY ROAD #142 (60' STATUTORY WIDTH) WAS MONUMENTED 30' EACH SIDE OF THE EXISTING ROAD CENTERLINE SINCE NO ACTUAL DEEDS HAVE BEEN EXCHANGED AT THIS TIME BETWEEN THE COUNTY & PRIVATE LANDOWNERS.

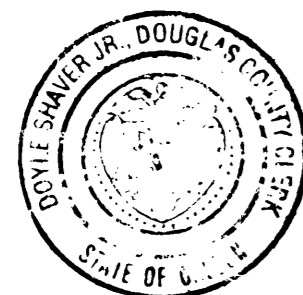
